ROLL CALL – The Raleigh County Board of Education met in regular session on Tuesday, May 24, 2022 at 5:30 PM in Munson Hall at the Raleigh County Schools Central Office with the following members present: Vice President Jack G. Roop, Ms. Marie Hamrick, Dr. Charlotte Hutchens, Mr. Richard V. Snuffer II and Mr. C. David Price, Secretary. President Larry D. Ford was absent.

CALL TO ORDER

Vice President Jack G. Roop called the meeting to order.

 - Supt. Price was excited to announce the WV Supreme Court has tentatively scheduled to hold hearings October 18, 2022 at the WWHS Auditorium for High School Civic students from Raleigh and surrounding counties to attend.

 - Attendance Director Kim Lacy shared both the 8th month and 9th month attendance reports. Mrs. Lacy stated the current student enrollment for the 8th month was 10,127 without Pre-K, with an attendance rate of 90.268 and homeschool totals were 1,121 students. The current student enrollment for the 9th month was 10,122 students, without Pre-K, with an attendance rate of 89.426 and homeschool totals were 1,137 students.
