ROLL CALL – The Raleigh County Board of Education met in regular session on Tuesday, June 14, 2022 at 5:30 PM in Munson Hall at the Raleigh County Schools Central Office with the following members present: President Larry D. Ford, Vice President Jack G. Roop, Ms. Marie Hamrick, Dr. Charlotte Hutchens, Mr. Richard V. Snuffer II, and Mr. C. David Price, Secretary.

CALL TO ORDER

President Ford called the meeting to order.

 - Superintendent Price stated the WV School Building Authority awarded Raleigh County Schools \$1,000,000 for the Park Middle School Gymnasium Project. Superintendent Price also provided facilities project updates.
