Called to Order President Ricky Steinkamp called the meeting to order at 6:30 p.m.

Prayer Dr. Hall

Open Forum Guests had no comments during Open Forum. Ricky Steinkamp suggested considering an additional ag teacher to prepare someone to replace Mr. Hunter at a point in the future when he decides to retire. Dr. Hall presented a Title I report. This year, Crawford ISD will receive just over \$59,000 in Title revenue. Those funds will be designated for supplies and salaries for reduction in class size. Dr. Hall also stated that there have been some recent concerns over the "Lockdowns" at the elementary school. The district is following protocol on the lockdowns. Parents are concerned. They want to know when the campus goes in to lockdown. Dr. Hall reported that the district would try to do a better job of notifying parents in a timely manner when a lockdown occurs. Chad Lewis expressed concern over the majority having to pay for the actions of the minority.

Superintendent Report Dr. Hall reported on the successes of our fall activities (Cross Country, Volleyball, and Football). We discussed dates for the

December meeting and dinner. Training for Orientation to the Education Code is coming up December 5. Current enrollment is 582. The facilities planning committee met on Sunday, November 18. The group will meet again on Monday, January 14 to finalize the report to be presented to the board on January 21. For security purposes, projects for the security fence, controlled access, and bus cameras have already begun.

Consent Items

Mr. Scott Pearson moved and Mr. Michael Wiethorn seconded the motion to approve the consent items including minutes from the October 15th regular meeting and monthly financial report. The motion passed.

Innovative Course

Mr. Michael Wiethorn moved and Dr. Roger Williams seconded the motion to approve innovative course N1280041 Social Intelligence for ESL Students. The motion passed.
