REPORT OF THE PRINCIPAL:

The high school soccer team attended the meeting and shook hands with the board. Mr. Grimm thanked the board for all their financial help on behalf of the students and athletics. He shared his appreciation and stated the students are a great group, committed to their schoolwork and athletics. He noted wherever the team played how the public commented on the team's good behavior, sportsmanship and positive attitudes. Sport commentators complimented them while announcing at their games.

PRESENTATION BY PRESCOTT ATHLETIC COACHES: ATHLETIC EXPECTATIONS OF THE MODEL TIGER
