

1.00 - Purpose and General Information

Au Gres-Sims School District is requesting responses to this Request for Proposal (RFP) to enter into a contract with a qualified trade contractor to provide construction services to the Au Gres-Sims School District for the replacement and construction of its Baseball Dugouts.

Proposals received after the Closing Time will not be accepted or considered. Delays caused by and delivery, courier or mail service(s) will not be grounds for an extension of the closing time.

1.02 — Information Meeting

A pre-bid meeting is not planned, although it is recommended that the site be visited to verify the exact location of the project.

1.03 - Construction

The demolition and construction need to be finished by April 1, 2023.

1.04 – Status Inquiries

Inquiries should be made no later than three (3) days before Closing Time. The District reserves the right not to respond to inquiries made within three (3) days of Closing Time. Inquiries and responses will be recorded and posted on the Website. It is the responsibility of the Proponent to check the Website for Addendums before submitting their proposal.

2.00 - Required Information

The proposed bids must be honored and firm for a period of 90 days upon approval. Contractors may be asked to present the proposal in-person during the RFP process.

2.01 - Familial Disclosure Statement

Each Proposal shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the Contractor and any member of the Board or Superintendent. Bids not accompanied by a sworn and notarized statement will not be accepted by the Board.

2.02 - Iran Economic Sanctions Act Certification

Each Proposal shall be accompanied by a certification required by the Iran Economic Sanctions Act that the bidder is not an Iran-linked business. Bids not accompanied by such a certification will not be accepted by the Board.

2.03 - References

The bid must include 3 references in an educational setting, or other comparable jobs. The District reserves the right to call and properly vet the vendors. After submission, the Board of Education will be the final authority on vendor that will be selected. The Board of Education reserves the right to reject any or all bids. Thank you for your consideration on this project.
