2024 - 2025:

Student Phase-In: 5th birthday between Sept 2 and June 2

Teacher to Student Ratio: 1:10, contingent on funding

2025 - 2026:

Students 4th birthday by September 1.

The phase-in can be faster if it allows for stand-alone UPK/UTK classrooms, in classrooms fitting the space, bathroom, and playground requirements.

> All TK/PK programs in school are designed for students who are not 5 at the start of the school year and are old enough to enroll in the traditional kindergarten classroom.

MTUESD Next Steps:



April 2022 – ongoing:

TK programs.

Disseminate UPK Questionnaire at the Kindergarten round-ups at each site and on-going

Monitor enrollments for both TK and K to determine continuing with a blended program or stand- alone program for TK and for K

Resolution in the Matter of the Expansion of Full-Day TK Application (attached)

Complete and Submit Application for the California Preschool, Transitional Kindergarten, and Full-Day Kindergarten Facilities Grant Program funding (attached)

June 2022 – June 2023:

Have a TK – K blended class at each school site; Staff with 1 teacher and trained paraprofessionals to meet the 1:12 ratio, full-day.

Review and Adopt curriculum specific to Tk and K, with staff development embedded in adoption

Assess and plan implementation continuance for the 2023-2024 school year.
