The minutes of the January meetings, claims for payment, financial reports and open enrollment applications were discussed. Moved by D Dinkla and seconded by L Dinkla to approve the consent agenda items. Motion carried 5/0.

Mr. Blake addressed the Board and explained how he is using SBL&G from state standards to assessments to lesson plans in his classroom.

Mrs. Mahaffey presented the winter testing results as compared with fall and last year. Mrs. Maas presented detailed information on the screening procedures, progress monitoring and individual factors at Adair-Casey that contribute to test scores.

Classified staff will receive the stipend in 4 equal payments to be made after the completion of each school quarter. Motion carried 5/0. Substitutes will be addressed at a later date.

Moved by D Dinkla and seconded by Bireline to accept the quote from SIRWA in the amount of \$61,142.75 for rural water installation. Motion carried 5/0.

Moved by Bireline and seconded by B Carney to approve the hiring of Jean Carnoali – 5th grade teacher, Kellie Lewis – JH Guidance, Brittany Cullen – 6th grade teacher, Jerri Harding – dishwasher, Savana Fuller – JH track coach, Shelby Bee – JH track coach, Alexis Widen – Elem Associate and Randall Harding – part time custodian. Motion carried 5/0.
