Dr. John Spevak from the Los Banos Rotary Club expressed his thanks to the Los Banos FFA for participating and to the Merced College Los Banos Campus for hosting the Rotary Speech Contest. He introduced two of the four winners: 3rd place Larry Borelli and 1st place Emma van Lobensels. The other two winners were Ava Menefee who placed 2nd and Lillian Kanemto who placed 4th. Both Larry Borelli and Emma van Lobensels said a few words. Dr. Spevak also spoke about the Colleen Menefee Memorial Bench project.

Public Forum

Los Banos High School Student Representative to the Board, Jacinta Brown Student Report reported on the many activities at Los Banos and Pacheco High Schools.

Jennifer Wilkin, LBTA President began by stating that it was great to back in a LBTA Report room full of people who are following the rules to keep everyone safe. She said there has been a lot of controversy regarding the vaccine mandates for students and staff. She said that LBTA understands that the Board cannot make decisions that go against State Laws and Mandates but she said that 67% of LBTA stands behind having a choice in whether to get vaccinated or not as a condition of employment. She shared a letter to the CTA President asking that they advocate at the state level for vaccination choice. She thanked everyone for keeping schools safe for students and staff and that it has been a rough couple of weeks.

Dr. Marshall started his report by thanking the families for their patience during the district's response to the Omnicron Variant surge last month. He said that he thought it had peaked and that the cases in the district were rapidly declining. He gave kudos to the fiscal team in advance for the audit report that will be presented later in the meeting. He shared some good news regarding students throughout the district: PHS Band and Band Director, Amanda Gieseke for the Percussion team taking first place at the Central Valley Guard and Percussion Competition. The PHS Percussion team is the defending Champions and have held the title since 2018. PHS participated in the Merced County Academic Decathlon. This was the first time that PHS formed a team to do so. All five students won individual awards. LBHS had seven students attend the Project Competition at the Merced County Fairgrounds. Several students were recognized and received awards. Alondra Castillo-Sanchez, a 6th grade student at RME Miano won the Healthy Air Living Competition. Her artwork is featured in the agencies calendar publication. He stated that he had great time at the Virtual CTA Dinner event and thanked them for the invitation. He finished his report by reminding everyone about the final virtual SB 328 meeting that was scheduled on the 16th at 5:30 p.m. He encouraged everyone to participate in the process.

Superintendent's Report:

Amer Iqbal, Assistant Superintendent of Administrative services introduced Scott Facilities Report Parrish from Mangini and the project manager and architect for the PHS Addition Project. He gave on update on the reasons for the delay on the project. The updated project completion time is now August 29th.

Anthony Parreira stated that he did not like starting the meeting the way it did. He stated that the rules had to be followed. If the District didn't follow the mandates and laws that there would be repercussions. He said that mandates are laws under statutes in the State of Californa. Gary Munoz had no report. Marlene Smith said that even though the COVID numbers are going down, Merced County still is at 23% as opposed to the Bay Area being at a 9% positivity rate. She said that the community is exhausted and some are angry. She asked everyone to continue to protect themselves. She said that the Martin Luther King Day event was a success. The event was well supported by the City. She thanked Mrs. Cooksey from the PHS Black Student Union for having her students participate. She has been supporting the LBJH Girls basketball team and stated that they had a great season. Jessica Moran acknowledged the student's resilience through everything they have gone She congratulated the Academic Decathlon winners and the Speech contest winners. She said the speeches showed that the students were proud of where they came from. Margaret Benton reminded everyone to donate dresses for the Prom Dress drive at both High Schools. She said that Dr. Marshall was right, that we have amazing students and that the staff bring out the best in them. Gene Lieb attended the Firehouse event at LBHS. He said that there were not many people in attendance. He attended the virtual CTA event. He has been attending the LBHS and PHS basketball games. He said that he noticed that almost everyone was wearing masks. He said that he was looking forward to Read Across America week. Even if it was via Zoom. Ray Martinez gave kudos to the students for all of their accomplishments. He thanked the teachers for bringing out the best in the students.
