Student Report

Andrea Clarke, Interim President of LBTA congratulated Gene Lieb on running a LBTA Report successful campaign. She stated that LBTA looked forward to working with him. She spoke about the public being able to attend board meetings in person and said that it was time for the Board to quit meeting on Zoom. She has been to events with 500 people in the Gym with masks and no social distancing and that teachers teach
