Pacheco High School Student Representative to the Board, Abigail Hernandez, reported on the many activities at Pacheco and Los Banos High Schools.

Student Report

Andrea Clarke, Interim President of LBTA said that the year was off to a great start LBTA Report and that it was great to have the students back. She said that parent teacher conferences would be held virtually this year. Staff is concerned about the Tic Tok Challenges and the increased student violence at the school sites. She is hoping to see some safety training for teachers and some updated guidelines for all staff. She stated that it was good to see the recent decline in COVID cases and that it was due to everyone working together as a team to keep everyone safe.

Dr. Marshall began his report by thanking parents and the community for continuing to follow the COVID safety guidelines. There has been a dramatic reduction in COVID cases in the district. He asked everyone to keep up the good work. He

stated that the District has hosted several vaccine clinics and that the District offers rapid testing for staff and students on a daily basis. He shared that the District is involved in a project that recognizes the health care workers in Los Banos. The students in the District have been making handmade cards of appreciation for healthcare staff at Memorial Hospital, Los Banos. The District participated in the inperson Salute to Seniors Fair on September 24th. In addition to the Human Resources Department hosting a booth, students from Los Banos High School, Pacheco High School, and San Luis High School volunteered during the Bingo game. He said that he attended the Restorative Justice Conference held at Los Banos Junior High. He praised the staff and students for a successful event. He congratulated Los Banos High School for their successful WASC Accreditation visit. Dr. Marshall reported that the District is working implement Senate Bill 328 which goes into effect next school year. Under the new law in California, middle schools can start no earlier than 8:00 a.m., and high schools no earlier than 8:30 a.m. A task force has been formed and their goal is to have a schedule complete by the end of December 2021. He stated that like other districts across the nation, Los Banos Unified is dealing with the Tic Tok challenges on social media. He said that we are working closely with the Police department to come up with a community event to address many of these issues and to raise awareness.

Amer Iqbal, Assistant Superintendent of Administrative services gave an update on Facilities Report the open construction projects in the District. The PHS classroom wing addition is going well. The Henry Miller Parking lot project is in the final design phase. The restrooms at LBHS are just waiting to be hooked up to the fire alarm system. The Volta water tank is slated to be finished by the end of the school year.
