Mr. Martinez called the meeting to order at 7:00 P.M.

Call to Order

Board President Ray Martinez led the audience in the Pledge of Allegiance. After the Pledge, Mr. Martinez asked that everyone remain standing and asked for a moment of silence in remembrance Pacheco High School Custodian, Angel Robledo Jr., who recently passed away,

Pledge of Allegiance

There was one change to the agenda, Under Consent Calendar, Item B, there was a revised Report of Certificated Employment submitted. There were 7 public comments received. The public comment emails were read by Ray Martinez and were posted to the District website for public view.

Public Forum

Board President, Ray Martinez, read the CSEA Report which started off with a poem by Chapter President, Lisa Souza about how everyone worked hard this year, and that we all are an intricate part of LBUSD. She stated about putting aside personal agendas and focusing on our goal, which is the education of our students. She finished her report by saying that Los Banos Unified School District has a wide diversity of employees that go above and beyond for all students alike and that she believes that the diverse talent and heedfulness that makes the District an exceptional place for students to learn.

CSEA Report

Board President Ray Martinez read the report from Jennifer Wilkin, LBTA President. The report started by asking the question, "what will next year look like?" She said that LBTA would thank those of you that reached out to teachers during National Teachers Appreciation and for California Day of the Teacher. She listed the recipients of the WHO (We Honor Ours) awards. Francine Baker, Jaclyn Ritchie, Vern Hixson, and Jeff Miller are the LBTA members that were honored. The CTA Gold Award is given by local chapters to individuals, businesses, or organizations who go above and beyond to support the students in their area. The two recipients of the Gold Award were the Los Banos Chapter of CSEA and Los Banos Rotary Club.

LBTA Report

Dr. Marshall began he report by sharing all of the staff recognitions that were taking place in the month of May. He gave accolades to the Pentathlon team from WUES for taking first place in the County competition for the 10th year in a row. Creekside Junior high also placed in the competition as well. FFA State Star finalist. PHS and LBJH took top honors at the MESA Regional competition in Fresno. CTA honored HME for their Feed the Need Program. He stated that Sergio de Alba from RME received a Champion of Civics Award and that Mrs. Amanda Hazan-Sanchez and Carissa Griffith from PHS were recognized as National Pre-AP Faculty members. He reminded everyone that we are continuing with free COVID testing every Wednesday at the District Office and that there will be a vaccine clinic at PHS for everyone ages 12 and up. He reiterated that next school year, LBUSD is returning to a five day a week, regular schedule.

Director of Fiscal Services, Alejandra Garibay presented the facilities report. The B Street traffic light is near completion and should be operational in the following week. The shade structure at Creekside Junior High and Lorena Falasco Elementary are complete. The Los Banos High restroom modular project is underway and should be completed by the end of the summer. She stated that on May 20th, the district will be opening bids for the construction of the additional classroom wing at PHS.

Margaret Benton attended the Scholarship Awards ceremony at LBHS and said that it was well organized and that \$63,000.00 in scholarships were awarded. She said it showed the dedication of the parents, teachers and students. She apologized to the community for not reaching an agreement for a provisional appointment to the Board and now the County has stepped in. She asked everyone to research the candidates in the area and to vote. She apologized for the lack of decorum and lack of respect displayed and that the focus needs to return to the children. Gary Munoz thanked all the teachers for their efforts. He wanted to let the teachers know that they were all appreciated. He commended District staff on the plan for working with students due to learning loss. He thanked Mr. Sutton for sending out a flyer with the upcoming end of the year activities. He congratulated Nancy Velador on a successful reclassification ceremony. Anthony Parreira also attended the LBHS Scholarship night. He said they had it set up to make everyone comfortable and that it was an enjoyable evening. He had the opportunity to read 75 senior scholarship applications and that the essays were outstanding. He remarked about all the students with high GPA's and that many were going to prestigious colleges/universities. He said that it shows that everyone is doing the right things in providing the students with a strong education and preparing them for college. He wished all of the student's good luck and congratulations. He is excited for students to be returning to 5 days "all in" in the fall. Kids have missed the social aspect of school and that it is really important for them to learn to share and interact with others. Sports, FFA, Band, Choir are all important for students to become great community members. He thanked the classified staff for all that they have done in the past year. Information Systems for all of the work providing technology support, Custodians for keeping everything deep cleaned, grounds for keeping the sites looking nice, and Bus driver who worked with students in Pods. He also acknowledged that Administrators had a lot do in the past year with keeping everything moving forward in an ever changing environment. He apologized to the community for spending \$30,000.00 unnecessarily. He thanked everyone for the messages and comments. He is extremely upset about the outcome and now we have to live with the consequences. He thanked everyone for contacting him and for submitting public comments. He said that the public comments received tonight were indicative of the comments that he received. He finished by saying that he was excited to see that the traffic light at B street was up and working. Marlene Smith said thank you to all teaches. She also congratulated the four teachers who were recognized by CTA at their awards event. She congratulated CSEA and Rotary who received awards from CTA as well. She said that she would like to see the

He said he is continuing to attend on-line seminars related to school district and school boards that a working towards bringing students back to campuses full time. He thanked all of the teachers and staff. He said he was impressed and thankful for all everyone has done this past year. He thanked the public for the comments, both good and bad.
