## LOS BANOS UNIFIED SCHOOL DISTRICT MINUTES OF THE REGULAR MEETING OF THE BOARD OF EDUCATION April 8, 2021

Mr. Martinez called the meeting to order at 7:00 P.M.

Call to Order

CSEA Report

Board President Ray Martinez read the report from Jennifer Wilkin, LBTA President. The report started by stating that March and April have been busy months for their members and the community. She said that many students have returned to LBUSD campuses for Hybrid instruction and teachers are adjusting and working harder than ever. She wrote that LBTA wants LBUSD to be a Lighthouse District, to be the leaders that other districts look up to. She stated that she believes the district made the right decision in not rushing to fully open. Even though many teachers have been vaccinated, students are still not able to receive the vaccine. She stated that the COVID Safety Plan and MOU regarding Hybrid Instruction put many things in place to help ensure the safety of staff, students and the community. She said that they were extremely grateful to all district staff for the work everyone is doing to make the best of the Hybrid schedule for the kids.

LBTA Report

Dr. Marshall began his report by thanking the Los Banos School community for another smooth return to in-person learning with the return of the secondary students this week. He said that in his observation, the students are excited to be back in school and that this sentiment is shared by staff and parents that he has had the opportunity to speak with. He thanked the labor partners for working with the District to make this happen. He stated that there are many districts in the state and nation that are still working through this. LBUSD was able to figure it out and that he was proud of that. He stated he would be posting information regarding Return to In-Person Learning FAQ's to the district social media sites and blog on Friday the 9<sup>th</sup>. He finished his report by sharing a chart that showed the projects that have recently been completed and took a moment to highlight them.

Superintendent's Report:

Assistant Superintendent of Administrative Services, Amer Iqbal presented the Facilities Report facilities report. The traffic light at B Street and Place Rd has been installed and they are working on the electrical and underground wiring. The Pacheco High School additional wing is being put out to bid and that they are at the initial phase of the Loftin Stadium project.

Trustee Reports

Margaret Benton said that LBUSD has the best staff and that she appreciated everyone pulling together to get students back in classrooms. She is getting great feedback on Facebook and emails. Jessica Moran attended the Parent Institute and was able to speak to the parents about being on the School Board. She received a lot of positive feedback from the Spanish speaking parents, and that they were happy that students were returning to school. She participated in a texting campaign to spread information regarding access to vaccines. She commended the Teachers, Administration, classified staff, parents, and students for all that they have done. Marlene Smith said that she has been advocating in the community about vaccines. She was happy to hear that the Governor wanted to have everything opened up by June 15th. She attended the Virtual Challenge Day at Creekside Junior High. She said that many of the students wanted to know when they could go back to school. Anthony Parreira said thank you and that he appreciated the certificated and classified staff for getting us through the past year. He said that he truly appreciated all that was done as it was unchartered territory for everyone. He hopes that we are able to get back to some sense of normalcy in August and is looking forward to it. He wanted to also thank the parents and students who have done all that they could do to make it work at home. Ray Martinez stated that it is amazing to come through tough times. It was a team effort and that even though we are not out of the woods vet, we have turned a corner. He said it is great hearing the happy chatter of children at the parks and school sites again. He also participated in Challenge Day at Creekside Junior High and that enjoyed interacting with the students,
