## LOS BANOS UNIFIED SCHOOL DISTRICT MINUTES OF THE REGULAR MEETING OF THE BOARD OF EDUCATION March 11, 2021

Via ZOOM

Mr. Martinez called the meeting to order at 7:00 P.M.

Call to Order

PRESENT: Ms. Benton, Mr. Martinez, Ms. Moran, Mr. Parreira, Ms. Smith Roll Call ABSENT: Mr. Munoz.

Board President Ray Martinez led the audience in the Pledge of Allegiance. After the Pledge of Pledge, Mr. Martinez asked that everyone remain standing and asked for a moment Allegiance of silence in remembrance of long time school board member Colleen Menefee who recently passed away.

On a motion by Member Benton, seconded by Member Smith, the agenda was approved as stated. Ayes: Benton, Martinez, Moran, Parreira, Smith; Noes: 0; Absent: Munoz. Motion carried.

Approval of Agenda

There were two public comments received prior to the deadline. One was in regards to appointing a new board member vs. electing one. The second was in regards to Classified employees and their flexibility during the pandemic. All comments were sent to the Trustees prior to the meeting and posted to the District website.

Public Forum

Board President Ray Martinez read the report from Lisa Souza, CSEA President. CSEA Report The report started by stating that the Classified employees have been repurposed, reinvented and reorganized their daily activities multiple times during the pandemic. She stated that classified staff is excited for students to return. She wrote about her continuing advocacy for equality in education for all children. She also reiterated her stance that all employees of the District should be considered "essential workers" and that equality in the workplace is a must. She stated that the same respect that is shown to the Superintendent should be shown to a custodian. She said that trust instills motivation and confidence to perform the job to the best of one's ability. She highlighted the many types of classified staff positions and the hard work that they have put in since the beginning of the pandemic. New protocols are being put in place to be the same district-wide as this sets expectations and standards for their members and will be better able to deliver the needed results. She stated that there are 39 different classifications that make up the LBUSD classified personnel staff. She reported that the arranging and rearranging schedules and adapting to every change the district makes or agreement they enter into creates more extra duties for classified employees. She said that their focus remains providing support to administration, teachers and most importantly the children of the community. She ended the report by saying, Los Banos Unified Classified Employees will continue to build the bridges our students need for a better tomorrow.

Board President Ray Martinez read the report from Jennifer Wilkin, LBTA President. LBTA Report The report started by stating that Teachers from all levels have been attending conferences to improve their education and prepare for the return of students to campuses. She gave a shout out to the all of the Special Education and ELD teachers. She stated that TK through first grade teachers have been excited to

welcome students back in the classroom. It also stated that the negotiating team was pleased to have come to an agreement that ensures the safety of students and their members as they move to bring more students back on campus. She wrote that 91% of the members who voted, voted in favor of the MOU. The report ended with the hope that our county continues to see a decline in COVID-19 cases and we can continue to bring students back at the secondary level.

Dr. Marshall began his report by commending the staff for a smooth welcome back to in-person learning for the TK, K and First graders. Grades Second through Sixth were due to return on the 15<sup>th</sup>. Secondary grades are scheduled to return on April 6<sup>th</sup>. He thanked Mrs. Sarah Elam for inviting him to read to her Kindergarten class. He gave kudos to Westside Union Elementary for advancing to the next level in Imagine Learning's National March Madness Contests. He congratulated Sergio de Alba for winning the MCSBA Mini Grant that would be used for STEM activities. He finished his report by sharing that he attended the celebration of life for Colleen Menefee. He said he learned so much about her and the great things she did for Los Banos Unified School District and called it a fitting tribute for a remarkable woman.

Superintendent's Report:

Assistant Superintendent of Administrative Services, Amer Iqbal presented the facilities report. The shade structures at Creekside and LFE are progressing. The B Street traffic light is scheduled to delivered and ready for installation soon. The cracked concrete report from Grasslands is being reviewed by legal counsel. The Los Banos High School restroom will be ready for a bid approval at the next regular Board Meeting in April.

Margaret Benton said that Los Banos experienced a devastating loss with the passing

of Colleen Menefee. She was a Rotarian, and lived the motto, "Service Above Self". She was a friend to the Arts as a member of the Arts Council, she started "Wee Readers" at the public library. She shared an article from a mother that highlighted what children have been going through since the start of the pandemic. She said the kids are the real super heroes. She reminded everyone to hug their kids. She said in addition to recognizing the Certificated and Classified Staff, we also need to be recognizing our students. Marlene Smith expressed her sympathies to the family of Colleen Menefee. She shared a story of how she worked with Colleen to organize the first NAACP Martin Luther King Event in Los Banos. She reminded her family to focus on all the good moments they had with her. She acknowledged all that Colleen did for Los Banos Unified School District and the City of Los Banos. Anthony Parreira stated that Los Banos lost a remarkable woman on February 25th. Colleen Menefee was a school board member for 26 years. She was the heart of the community. She was the first woman Rotarian. She started the Empty Bowls fundraiser in Los Banos.. Her heart was always focused on what was best for kids. She was a huge supporter of the library, the founder of the Tree Commission, and an active member of the Arts Council. He expressed his condolences to her family. He stated that enjoyed seeing all the Facebook posts with smiling students heading back to the classroom for the first day of in-person learning. He had opportunities to read on Dr. Seuss day to Mrs. Elam's class at Mercey Springs Elementary and to Mrs. Parreira's class at Los Banos Elementary. He thanked Dr. Richey for obtaining all the signatures for the 2<sup>nd</sup> reading of the Course Adoptions on the agenda. He said he has been receiving tons of comments on a video posted on Los Banos Talk. He reminded everyone that Board Members have no jurisdiction over other Board

members, that they are elected officials. He said he appreciates everyone that emails him with comments. Jessica Moran also acknowledged the contributions made by

Colleen Menefee to the District and to the City. She extended her condolences to the family. She thanked the Teachers, Classified Staff and Administrators for preparing for a safe return of students to campuses for in-person learning. She enjoyed the back to school video that the staff at LBE created and shared. She encouraged everyone to get vaccinated and to register on the County vaccine website. Ray Martinez started his report by say that we need to work together in the spirit of unity, no struggles, no growth. He thanked everyone for all of their hard work and that if everyone worked together we will get through it. He also commented on the passing of Colleen Menefee. He said that he only knew her for a short time and that her heart and passion for servitude was obvious. He stated that Gary Munoz was recovering from surgery and asked everyone to keep him in their thoughts and prayers. He said that he was excited to see kids coming back and that we need to keep pushing to do what needs to be done to get all students back to school. He finished his report by commending Trustee Jessica Moran on her new position at Merced College, Los Banos Campus.

After a presentation by Fiscal Director, Alejandra Garibay, a motion was made by Member Benton and seconded by Member Smith, Trustees approved the Second Interim Budget and certified that the District will be able to meet its financial obligations for the current year and two subsequent fiscal years.
