Dr. Marshall started his report by commending everyone for a great first couple of weeks. He stated that since he lives in Los Banos he gets to talk with many in the community that recognize that the District is putting forth their best effort to serve students. He thanked the local businesses who have been providing lunch for the staff at various sites. He said that he will be starting a series of virtual chats with the school community. These will be basic conversations designed to give us feedback on how we are doing. He shared that on Friday the 11th he was starting a series of videos that will highlight the great things that the District is doing with Distance Learning. Dr. Marshall said to access the District website and social media platforms for them soon. He announced that Los Banos High School and the Child Nutrition Department are teaming up with Memorial Hospital Los Banos to present a COVID-19 Wellness Campaign for the community. It will occur on September 14th and September 21st. He shared that LBUSD is one of three districts in Merced County that will participate in a National Education Partnership. This provides the District the opportunity for access to a National Network in public education. He reminded everyone that the next day was the 19th anniversary of the events that occurred on September 11, 2001.

Superintendent's Report:

Amer Iqbal, Assistant Superintendent of Administrative Services gave an update of Facilities Report various projects throughout the district. He said that Grasslands Elementary was in the final stages of the punch list phase. The plans for the Lorena Falasco Elementary and the Creekside Junior High Shade structures are with the Division of the State Architects office and when they are approved, construction can begin. The LBHS modular restroom plans were approved but before construction can begin there are minor projects that need to be completed such as ADA accessibility. President Anthony Parreira asked about the problems with the sidewalk at Grasslands Elementary and Mr. Iqbal said that was one of the items on the punch list that was being addressed.

Anahi Rodriguez had no report. Luis Castro had no report. Ray Martinez thanked the teachers and administration for getting things worked out and thanked them for their patience. Marlene Smith said she has talked to many community members that are giving thanks to the teachers and now have a better understanding of what they deal with daily and they are hoping to have their children back at school soon. She stated that COVID-19 is still in Los Banos and reminded everyone to protect She stated that Memorial Hospital Los Banos was having a drive through flu vaccine clinic on September 28th and October 16th and 30th. reminded everyone to be safe. Gary Munoz had no report. Margaret Benton thanked all the staff and teachers. She said that even though there was an internet crash on the first day everyone worked hard to get it resolved. Ms. Benton said she took a walk around the Grasslands Elementary Campus and it was beautiful. She reminded everyone to stay safe. Anthony Parreira talked to many teachers of all levels and said that this has been the hardest type of teaching that they have ever done. He thanked the teachers, Administration, IS staff, Classified and Child Nutrition staff for all that they have done. He shared that the Child Nutrition staff is passing out seven days' worth of breakfast and lunches to all families with children between the ages of 1 and 18 regardless if they are students of the District.
