## LOS BANOS UNIFIED SCHOOL DISTRICT MINUTES OF THE REGULAR MEETING OF THE BOARD OF EDUCATION March 9, 2023

Mr. Parreira called the meeting to order at 6:00 P.M.

Call to Order

The regular session was opened at 7:00 p.m. by Board President, Anthony Parreira

Regular Session

The audience was led in the Pledge of Allegiance by Past Board Member, Dennis Areias. After the Pledge, Board President, Anthony Parreira, asked everyone to remain standing for moment of silence for past employee, Bella Flores-Ayala, Employee Dawn Lais, and Retired long time administrator, Manuel Gastelo, who had all recently passed away.

Pledge of Allegiance

On a motion by Trustee Gattuso, and seconded by Trustee Smith, Trustees approved Approval of the agenda as submitted. Ayes: Gattuso, Lieb, Moran, Munoz, Parreira, Smith and Agenda Valadao, Noes: 0: Absent: 0. Motion carried.

Members from the Los Banos High Boys and Girls Wrestling Teams were Recognition/ recognized.

Introductions

Andrea Clarke, 4th grade teacher at RME, thanked trustees for reading to her class Public Forum during "Read Across America" week.

Jeff De la Cruz, Social Studies teacher at PHS, said he brings students to the Board meetings so they can see how government works. He lets his students know that it is the right of people to petition the government. He said he was recruited 23 years ago to work in Los Banos. He took a chance on Los Banos and has not regretted it. He said that this is the first time in 23 years that he feels unappreciated. He said that he appreciates his colleagues who are in attendance. He believes in the School District, and he wants the School District to Believe in him.

Kathrine Twomey, Student Representative from PHS reported on activities and Student Report events from LBHS and PHS.

Lisa Nunes, CSEA President, stated that she typically uses her report to shine the CSEA Report light on a specific classification but felt tonight that she needed to do something different. She said that she feels that all classified staff are pretty awesome. As Chapter President, she tries to make everyone feel seen and heard and treated as equals. She stated that the negotiation team needed to represent everyone. There are classified staff that work 2 hours per day and those that are 8 hours 247 days per year. She said that they did their best to reach an agreement that was best for everyone because they are not a one size fits all group. She finished by asking the Board to ratify the agreement that was on the agenda.

Jennifer Wilkin, LBTA President started by saying that she was one of "Those LBTA Report People". She then spoke about various teachers throughout the District that are doing great things. She said that many teachers were using donor sites to obtain materials for their classrooms. She stated that out of 511 of "Those People", 150 were commuters and that 80 were looking for jobs closer to home. She said the cost of gas and quality of life were factors. She said the COLA is increasing yet morale is at an all-time low. She said the Superintendent says he does not negotiate in public, but she asked him to participate in person at the next meeting. She asked him to put students first.

> Superintendent's Report:

Dr. Marshall started his report by stating that it was nice to see LBUSD continue to return to normalcy. He attended the Los Banos High School 26th Annual FFA Week staff appreciation lunch at LBHS. He said the food was delicious. He stated that the Los Banos Rotary Club successfully brought back its Empty Bowls fundraiser on February 23. He gave kudos to the secondary ceramics teachers, students, and Rotary members who worked to create the bowls. Deo Brasil, Principal of LBJH, was also recognized for her leadership efforts on the project. He said that the inaugural "Breakfast with the Superintendent" was held on March 6th at LBJH. He said there was a great turnout and that a lot of useful feedback was received. He praised the translator that worked at the event. The goal was to provide attendees with a comprehensive update of what is occurring in the district. The format was intended to be like the "Coffee with the Principal" framework that is currently being utilized by elementary sites. The next event will be structured to be less formal. He stated that he enjoyed reading in the classrooms as part of the "Read Across America" initiative. He read to students at Grasslands Elementary, Westside Elementary, and Miano Elementary Schools. He commented that he had a newfound respect for teachers in the primary grades. He said that he is looking forward to participating in a State Conference the following week. Dr. Richey, Chief Academic Officer and him are doing a presentation with State Department Officials; he will be part of a panel and shared that he will be facilitating a session that involves the Governor and R. Linda Darling Hammond from the State Board of Education. He finished his report by stating that the District will continue to negotiate in good faith.

Sherry Munday, Manager of Facilities and Special Projects gave a presentation highlighting the updates to the Loftin Stadium Phase I project, the HME/FOT parking lot, and shared a list of upcoming projects including: the LBHS Fire Alarm Replacement; LBHS LED Lighting; Loftin Stadium Solar; LBE Parking lot replacement: TK Center.

Facilities/ Maintenance Reports

Gene Lieb said that the Empty Bowls fund raiser was a great success. He thanked Trustee Reports LBJH Principal, Deo Brasil. He said that the ceramics teachers and students from CJH, LBJH, LBHS, and PHS went above and beyond making the bowls for the event. He said that 17 different community groups/businesses provided soup. He attended the PHS Crab Feed that benefits both Baseball and Softball at the site. He attended the LBHS FFA Staff appreciation lunch and was able to hear the FFA Creed in both Spanish and English. He read to Mrs. Clarke's 4th grade class at RME. He attended the Breakfast with the Superintendent and was able to speak to many parents regarding their concerns. He also attended the City of Los Banos' Arbor Day Ceremony. Students that placed in the art contest were given saplings to take home to plant. He spoke of attending the Parent Leadership Training Institute (PLTI) at LBJH and liked the message of communication that the training provided. He attended the Spring Choral concert at PHS. The choirs from PHS, LBJH, and CJH all performed. Lori Gattuso said that she enjoyed having the wrestling team and government students at the meeting and she thanked them for attending. She toured 4 school sites and enjoyed seeing the facilities. She read to as many classes as she could during "Read Across America" week and vowed to do better next year and pick a book that would be more engaging for the students. She asked to please be invited back. She attended many of the same events as Mr. Lieb and she thanked Stuart McCullough for the FFA Ag Appreciation lunch and said the meal was great. She enjoyed hearing the creed in both languages. Marlene Smith said that she went book shopping and read a wellness book to students during "Read Across America" week. She said the students were very interested and asked some great questions. She also attended the Spring Choral concert. She said that Ms. Cline engaged the crowd and that she enjoyed the singing of "We are One". She has been attending the girls sporting events at PHS. She stated that the Girls Track team has new outfits. She teaches one of the ROP classes at the Hospital for the Health Science Students. They have been working in the OB Department and in the OR. She said she really enjoys working with the students. She finished by wishing everyone a nice evening. Dayna Valadao said she visited the LBJH Ag department and visited the Chicken coops. She also visited CJH's Thinking Classroom. She read to 15 classrooms during "Read Across America" week. She attended the Arbor Day Celebration. She thanked Stuart McCullough for the FFA staff appreciation meal. Jessica Moran read the Dr. Suess book "Oh, the Places You'll Go" to students at Volta Elementary. She said that life is a balancing act and the group was very engaging. She attended the secondary Curriculum Council meeting. She is impressed with the teachers that were vetting software. She said she received a huge stack of scholarship applications that she was looking forward to reviewing. She told everyone to keep safe and warm. Gary Munoz started his report by stating he did not want to say "No Report". He had been ill during the last month and had to cancel reading to classrooms. In January he read to classrooms and said it was amazing. He attended the Safety Program at RME. He took the information that received at RME and shared in with parents who attend the PLTI at WUES. They shared their concerns about traffic safety at LBJH. He forwarded that information to Dr. Marshall. He finished his report by stating he had been snowed in while in Mariposa for the prior two weeks. This was why he missed reading to the students. He hopes to be able to read to them again soon. Anthony Parreira read at 5 schools to 15 classrooms. He thanked the teachers and the principals. He said that for 37 years of teaching in the district, he taught 7th and 8th grade students. He said that when he first started in the District he would play piano in the kindergarten

classrooms when they sang Christmas carols. He mentioned that kindergarten students scared him.

Dr. Sean Richey, Chief Academic Officer gave a mid-year update on the LCAP.
