 - Reduction in BOCES software contract:
 - Contracted Services Increases;
 - Reductions in Central Services and Pupil Transportation due to a decrease in energy costs;
 - Benefit Costs; and
 - Decrease in Long Term Debt.
- Outstanding variables include:
 - Evaluation of Personnel Changes and Program Structures;
