3. BOARD INTERVIEW PROCESS SELECTION

The second question will be asked and answered first by the candidate in the second seat, then by the candidate in the third seat, continuing until all candidates have answered. This procedure will be repeated for all questions.
- (2) All questions will be answered first by the candidate in the first seat, then by the candidate in the second seat, and so on until all candidates have responded to the questions.
