Involvement of Parents in the Title I Program

To involve parents and family members in the Title I program at Elliott Alternative Education Center, the following practices have been established:

The annual Title I meeting was held virtually at Back to School night on 8/20/2020.

Elliott Alternative Education Center conducts home visits to families of students who need extra assistance.
