JOB DESCRIPTION

INTERVENTION CENTER MONITOR

DEFINITION:

Under the direction of the Assistant Principal, supervise and monitor the behavior of students assigned to the intervention center; assist in the maintenance of an orderly and safe learning environment; maintain attendance logs and reports; provide referrals to additional services and programs.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Ensure effective supervision and observation of students assigned to the intervention center for behavioral concerns; compile instructional or testing materials from instructional staff; ensure students in the intervention center are occupied with school work; enforce classroom, school and District rules in the intervention center.
- Administer student roll call daily to ensure student attendance; monitor attendance logs and records; utilize computerized record keeping systems to record attendance and grades.
- Generate student achievement and/or behavior reports and attendance data and records, referrals and student activities; disseminate and collect students' assignments and materials that are provided by students' teachers.
- Ensure maintenance of a safe, clean and comfortable physical environment which conform with applicable standards of health and safety; provide safety and protection of assigned intervention center students.
- Perform a variety of administrative duties including maintenance of attendance records, referral forms and call slips; ensure adequacy of intervention center supplies.
- Effectively communicate and maintain cooperative relationships with those contacted during the course of work.

OTHER DUTIES:

Perform related duties as assigned.

REQUIRED QUALIFICATIONS:

Education and Experience:

• Any combination equivalent to: graduation from high school, or equivalent and some experience working with high school age students and those with behavioral concerns.

DESIRED QUALIFICATIONS:

- First Aid and CPR.
- District's Student Conduct Code.
- Two years as a supervisor of junior or high school age students.
- Associate of Arts Degree or higher.

Knowledge of:

- State and local laws and District regulations pertaining to the intervention center.
- · Communication strategies for students and adults.
- Methods of observing, evaluating and recording student behavior.
- Safety precautions and procedures.
- Local organizations and community services.
- Written communications skills.

- Record-keeping techniques.
- Telephone techniques and etiquette.
- Program philosophies and requirements.

Ability to:

- Supervise and monitor an intervention center for students with various behavioral issues.
- Prepare records and reports for students in the intervention center.
- Sufficient vision to read fine print, hearing to hear hand held radio conversation,
- Utilize communication and utilize hand held communication devices.
- Speak in a voice that can be clearly heard and understood on the telephone or hand-held radio, and in face-to-face conversations.
- Interact with children and adults in an effective manner.
- Maintain a healthy and safe environment.
- Work independently with little direction.
- Establish and maintain effective working relationships with others.
- Maintain records and prepare reports.
- Analyze situations accurately and adopt an effective course of action.
- Meet schedules and time lines.
- Plan and organize work.
