JOB DESCRIPTION

LEAD EQUIPMENT OPERATOR

DEFINITION:

Under the direction of the Senior Director-Maintenance and Operations, lead and participate in equipment operation, grounds and maintenance functions; train and provide work direction to assigned staff.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Oversee the maintenance and care of grounds to ensure clean, aesthetic and safe conditions.
- Ensure the proper installation, operation and repair of irrigation sprinklers and drainage systems.
- Oversee the moving of bleachers, furniture, and equipment; oversee the preparation of athletic fields and tracks.
- Oversee the installation and repair of asphalt, fences, concrete, and playground equipment.
- Plan for materials needed for maintenance, operations and construction projects and coordinate as necessary.
- Develop plans and schedules related to maintenance, operations and construction work as directed.
- Estimate time, material, and labor for maintenance, operations and construction projects.
- Oversee progress of maintenance, operations and construction projects in accordance with established guidelines.
- Attend bid walks, pre-construction and progress meetings as needed.
- Assist in the development of District standards, materials, and procedures.
- Assure the proper operation and maintenance of tools and equipment in the grounds department.
- Train and provide work direction to assigned staff.
- Orient new employees to their duties and responsibilities.
- In-service grounds department staff.
- Check the work of grounds department staff and document any deficiencies or progress.
- Attend meetings, conferences and in-service trainings as required.

OTHER DUTIES:

Perform related duties as assigned.

REQUIRED QUALIFICATIONS:

Education and Experience:

 Any combination equivalent to: graduation from high school and four years site maintenance, equipment operation, grounds maintenance or related experience.

Licenses and other Requirements

- Valid California Class A driver's license.
- Must provide DMV printout within five work days of offer of employment.
- Maintain participation in CA DMV Assessment System/Automatic Pull Program.
- Valid Medical Examiner's Certificate issued in accordance with the motor carrier safety regulations of the Department of Motor Vehicles.

Knowledge of:

- Operation, preventive maintenance and minor repair of a variety of grounds equipment
- Grounds maintenance procedures including mowing, edging, raking and weeding.

- Methods, equipment and materials used in landscaping, grounds keeping, maintenance and equipment work.
- Cultivating, fertilizing, watering and spraying of flowers, trees and shrubs.
- Basic record-keeping techniques.
- Oral and written communication skills.
- · Health and safety regulations.
- Principles of training and providing work direction to others.

Ability to:

- Operate and maintain a variety of power equipment and vehicles in the maintenance of designated grounds.
- Perform regular preventive maintenance work and minor repairs on grounds equipment.
- Perform a variety of grounds maintenance duties in the beautification of assigned grounds and landscaped areas.
- Communicate effectively both orally and in writing.
- Establish and maintain cooperative and effective working relationships with others.
- Understand and follow oral and written instructions.
- Maintain routine records related to work performed.
- Observe health and safety regulations.
- Perform heavy physical labor.
- Read and understand construction drawings, plans, and specifications.

WORKING CONDITIONS:

Work Environment:

- Outdoor work environment.
- Seasonal heat and cold or adverse weather conditions.
- Exposure to fumes, dust, odors, oil/grease, gases.
- Drive a vehicle to conduct work.

- Heavy physical labor.
- Seeing to operate ground equipment.
