JOB DESCRIPTION

MEDICAL PROCEDURES SPECIALIST

DEFINITION:

Under the direction of the Director of Special Education Local Plan Areas (SELPA) and under the supervision of a credentialed School Nurse, provide a variety healthcare services including first aid and emergency care; serve as a technical resource to students, parents and staff concerning health services, issues, problems and related information; prepare related records and reports.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- Under the direction of a credentialed school nurse, provide a variety of health services to students; screen and medical conditions of students; examine students for illness, injury and medical emergency; administer first aid as necessary; provide emergency care as needed, including anaphylactic shock, cardiopulmonary distress, dysreflexia, insulin shock, and other medical emergencies; ensure optimal health of students and staff; assist in ensuring related activities comply with established laws, codes, regulations, policies and procedures.
- Prepare student emergency information packet to assist in student transportation to a medical facility; compile information and prepare and maintain a variety of records and reports related to health services, screenings, tests, immunizations, financial activity and assigned duties; process and evaluate a variety of forms and applications; maintain students' Special Education Local Plan Area binder.
- Deliver Specialized Health Care Services to students as directed by the Physician's order and
 under direction of a credentialed School Nurse, and as indicated by the Individualized School
 Health Care Plan; perform intermittent clean catherization and assist student in self-clean
 catheterization; assist in tracheostomy tube suctioning using mechanical ventilators, ostomy care,
 drainage and percussion; administer tube feedings; blood glucose monitoring according to
 standardized procedural guidelines.
- Gather data regarding students physical condition and health in the areas such as height, weight, lice and other health conditions; monitor vital signs; notify appropriate personnel including school nurse of health conditions and related concerns as appropriate; administer medication per physicians orders and under the direction of a credentialed school nurse; monitor all supplies to ensure staff can adequately meet student needs.
- Establish and maintain cumulative health and immunization records and files for individual students; review records to ensure immunization data is current; assist in clerical duties and complete District insurance billing of licensed nursing duties where indicated; notify parents or appropriate staff of needed immunizations and other medical issues as appropriate; update and ensure accuracy of information related to screenings, procedures and medications.
- Serve as a technical resource to students, parents and staff concerning health services, issues, problems and related information; respond to inquiries and provide detailed and technical information concerning medications, immunizations, health care procedures and related laws, codes, rules, programs and regulations; make home visits as directed.
- Assist students and their families with resolving health issues; develop individual health care and
 emergency plans for students with special medical needs; refer students and parents to
 appropriate community resources for recommended health services; refer families to agencies to
 help in securing transportation as needed; follow up with parents regarding health care referrals,
 immunizations and medications.
- Communicate with students, parents, personnel and a variety of outside agencies to exchange
 information, coordinate activities and resolve issues or concerns; effectively communicate and
 maintain cooperative relationships with those contacted in the course of work.
- Operate a variety of medical instruments and equipment including thermometers, stethoscopes and screening devices; drive a vehicle to conduct work.
- Send and receive emails; notify school nurse in health care related email correspondence.

- Attend and participate in staff meetings and IEP's as required; assist in and follow emergency plans, related training and other in-services for staff as assigned.
- Drive a vehicle to conduct work.

OTHER DUTIES:

• Perform related duties as assigned.

REQUIRED QUALIFICATIONS:

Education and Experience:

 Any combination equivalent to: graduation from high school supplemented by college-level course work in nursing or a related field and two years of health care experience.

Licenses and other Requirements

- Current California Licensed Vocational Nurse (LVN), Licensed Psychiatric Technician (LPT) or Registered Nurse (RN).
- Valid First Aid and CPR Certificate issued by an authorized agency.
- Valid California Driver's license.
- Must provide a DMV printout within five work days of offer of employment.
- Maintain participation in CA DMV Assessment System/Automatic Pull Program.

Knowledge of:

- Health office practices, procedures and equipment.
- General practices, procedures and techniques involved in the identification, treatment and resolution of health problems.
- Health and safety regulations.
- First aid and CPR methods and procedures.
- Clean and sterile treatment techniques.
- Medical procedures associated with special health care needs.
- Basic anatomy, physiology, and medical terminology.
- Applicable laws, codes, regulations, policies and procedures.
- Operation of a variety of specialized medical equipment.
- Public health agencies and local health care resources.
- Oral and written communication skills.
- Interpersonal skills using tact, patience and courtesy.
- · Record-keeping and report preparation techniques.

Ability to:

- Provide a variety of health services to students and staff including first aid, screening of ill or injured students and emergency care.
- Serve as a technical resource to students, parents and staff concerning health services, issues, problems and related information.
- Prepare and maintain student immunization and health records and files.
- Under the direction of the school nurse, refer students and parents to appropriate community resources for recommended health services.
- Assist with screening students for various health and safety concerns.
- Observe health and safety regulations.
- Interpret, apply and explain rules, regulations, policies and procedures.
- · Compile and verify data.
- Assist in preparing records and reports.

- Communicate effectively both orally and in writing.
- Establish and maintain cooperative and effective working relationships with others.
- Determine appropriate action within clearly defined guidelines.
- Work independently with little direction.

WORKING CONDITIONS:

Work Environment:

- Health office/classroom environment.
- Subject to emergency medical situations.
- Driving a vehicle to conduct work.

- Dexterity of hands and fingers to operate specialized medical equipment.

- Lifting and moving students as assigned by position.
