### QUALITY ASSURANCE SPECIALIST

# **DEFINITION:**

Under the direction of the Manager-Software Development, perform variety of technical duties involved in quality assurance testing; administer user security rights and privileges, monitor system processes, and provide maintenance of District Custom Applications and assigned websites; develop and maintain custom application documentation for custom software applications and online software sites; oversee and maintain call logging and defect tracking database, including assignments to programmers and determining final resolution; identify, analyze, and document application defects for programmers.

## **ESSENTIAL DUTIES AND RESPONSIBILITIES:**

- Perform a variety of technical duties involved in quality assurance testing in support of the District's software development department; assist in the migration, configuration and integration of new District software applications.
- Assure consistent quality of software applications and validate quality assurances processes.
- Maintain and monitor Application Exception and Server Event Logs.
- Maintain various software applications to ensure proper functionality for phone systems and emails.
- Assist users in problem determination and solutions related to custom applications, both on site and via the call logging system.
- Administer end-user security for custom applications including user security rights and privileges as assigned.
- Produce and maintain Quality Assurance builds for custom applications being testing.
- Create and maintain internal and external websites.
- Create and manage software application build lists for the productions environment.
- Develop and maintain test plans; create work flow plans; schedule and perform testing to ensure applications are functioning according to written specifications.
- Develop and maintain documentation for custom applications including user guides, training materials and changes to applications; document and communicate enhancements and updates for custom applications.
- Receive feedback from Admin Users regarding new requests and enhancements; coordinate and facilitate meetings with Software Development Manager and Admin Users to discuss proposed changes.
- Conduct usability testing for custom applications; provide suggestions for design and functionality improvement.
- Run SQL queries to gather data for testing and troubleshooting software applications.
- Communicate with personnel, vendors, service representatives and outside agencies to exchange information, coordinate activities and resolve issues or concerns.
- Collaborate with other with Software Development team to create sample data that can be used to test user scenarios.
- Input data into an assigned computer system and generate a variety of computerized reports; initiate queries, compile information, process reports and manipulate data as appropriate.
- Prepare and maintain a variety of records and reports related to assigned activities.
- Attend meetings and conferences; plan and conduct in-service trainings in proper use of custom applications.
