### **GENERAL EDUCATION INTERVENTION BOARD CERTIFIED BEHAVIOR ANALYST**

#### **OVERALL RESPONSIBILITY**

Under general supervision, act as a consultant to administration, teachers, support staff, and students across settings to support student behavioral needs. Participate as a member of the educational team to design and supervise the implementation of classroom programs for students with autism using data-driven instructional and behavioral methodologies to decrease targeted maladaptive behaviors and maintain students in the Least Restrictive Environment.

#### **SPECIFIC RESPONSIBILITIES**

1. Provide oversight to the instructional program including classroom and school site supports needed for targeted students with behavioral concerns.
2. Use data to monitor, evaluate, and recommend instructional changes, additional supports, and or services based on interpretation of data.
3. Design and monitor early intervention programs for students with behavioral concerns.
4. Conduct Functional Behavioral and Functional Analysis Assessments as needed.
5. Develop Behavior Support and Behavior Intervention Plans.
6. Provide behavioral services to students, as well as modeling, coaching, instruction and support to staff to assist target students with behavioral concerns.
7. Participate in, coordinate, or conduct a variety of meetings, staff development, and trainings.
8. Complete training and guidance of teaching and support staff in the implementation of behavior plans.
9. Coordinate, complete training for, conduct coaching, assist with supervisor, and direct the work for support staff (paraprofessionals).
10. Prepare reports for IEP/SST and other student related meetings.
11. Assist to develop and support students into new educational placements.
12. Effectively communicate and maintain cooperative relationships with those contacted during the course of work.
