### BACKGROUND

In 1988, Modesto City Schools formed a partnership with the Center for Human Services (a not-for-profit community counseling agency assisting youth and families in Stanislaus County) to provide Student Assistance Specialists at the District's elementary, junior high/middle, and high schools. Student Assistance Specialists are trained staff of the Center for Human Services who work directly with students who have challenges at school that impede their ability to achieve in the classroom.

In the 2014-2015 school year, the District began contracting with the Center for Human Services to provide counseling services at targeted sites using primarily a behavioral consultation model which focuses on preventative support with parent and teacher training and direct counseling services as needed.

In June, our Board of Education approved a Local Control and Accountability Plan (LCAP) which included piloting a Family Support Specialist at three (3) targeted school sites.

### ISSUE

In order to continue to provide Student Assistance Specialist services, counseling support, and family support services, the contract with Center for Human Services must be renewed for the 2017-2018 school year.

### PROPOSAL

Students who have social, emotional, or psychological problems cannot gain maximum benefit from the educational program. Student Assistance Specialists will provide individual assessment and intervention for youth identified in need of prevention, intervention, or support services. Group and classroom presentations are also provided as requested.

Approval of Services Agreements with the Center for Human Services  
to Provide the Student Assistance Specialist Program, Counseling Services and  
Family Support Specialists for the 2017-2018 School Year

The Center for Human Services will provide Student Assistance Specialists for the equivalent of up to 223 days per week during the 2017-2018 school year at all Modesto City Schools sites, K-12. Services will be provided six (6) hours per day x 36 weeks per year x one (1) or more days per week at \$45.90 per hour.

The District will hire a total of 2.2 Mental Health Clinicians who will provide up to 77 hours per week of services at targeted school sites. The services agreement outlines with specificity the services to be provided at each site. Clinician support will be provided six (6) hours per day at \$47.00 per hour.

The Family Support Specialists will provide a variety of supports and interventions to parents, families, and/or students. The Family Specialists will provide strengths-based assessments and develop an individualized plan to assist the family and/or student in eliminating barriers to success. Services will be provided in the home and school and may include case management, linkage to resources and support services, parent education, and skill development. Family Support Specialists will be provided six hours per day at \$41.50 per hour.

Copies of the services agreements are available for review in the Special Education Office.

FISCAL IMPACT

The total estimated annual amount for the Student Assistance Specialists will not exceed \$2,300,000; the total estimated annual cost for the Mental Health Clinicians will not exceed \$150,000; the total estimated costs of the Family Services Worker will not exceed \$150,000. Total combined costs for services shall not exceed \$2,600,000.

The funding sources have been identified in the Local Control and Accountability Plan (LCAP 3.3.i), Coordinated Early Intervention Services (CEIS) money used to reduce suspensions and expulsions, District and Site Title I, Proposition 10 Grant money, and Special Education funds.





---

### BACKGROUND

Termite damage has been discovered at various locations at Modesto High School. The affected areas include classrooms, offices, and storage rooms. It has been determined that repair of the damaged spaces must be conducted before the beginning of the 2017/18 school year on August 14<sup>th</sup>. In addition, tenting buildings is required for treatment, which cannot be performed while school is in session.

On July 10, 2017, the Stanislaus County Office of Education approved proceeding with treatment and repairs without advertising for bids pursuant to Public Contract Code 20113.

### ISSUE

In order to perform treatment and begin repairs during the summer recess, it is necessary to declare an emergency situation and obtain Board of Education approval to proceed with remediation without advertising for bid.

### PROPOSAL

An emergency needs to be declared in order to perform the work in a timely manner, prior to the start of the 2017/18 school year.

### FISCAL IMPACT

The current estimated cost for treatment and repairs is \$100,000. Funding will come from Routine Restricted Maintenance.

### BACKGROUND

The Nutrition Services Department provides food, paper and janitorial products for the Basic Breakfast Program (BBP), Severe Needy Breakfast Program (SNBP), the National School Lunch Program (NSLP) and the After School Meal Supplements (AMS) as part of the USDA Nutritional and Sanitation Guidelines.

### ISSUE

The Nutrition Services Department provides food, paper and janitorial supplies to Modesto City Schools' cafeterias to help meet the USDA nutritional and sanitation guidelines. The estimated annual cost exceeds the current bid threshold of \$88,300; therefore, competitive bids were sought to meet formal bidding requirements.

### PROPOSAL

Bid #17-4655, Food Products, Bid #17-4656, Paper and Janitorial Supplies, and Bid #17-4657, Direct Ship Food Products, were sent to 115 vendors, posted on the District's website, and advertised as required by law. Twenty-seven (27) responses were received. The bid awards are for one year, with the option to renew for two additional one-year periods.

Bids are awarded to the lowest cost responsive and responsible bidders for each line item, and the estimated amounts for the purchase of food products, paper and janitorial supplies from these vendors are listed below:

The District will hire one Mental Health Clinician who will provide up to 32 hours per week of service at targeted school sites. An additional 8 hours per week will be devoted to documentation preparation purposes. Provider duties include, but are not limited to, conducting needs assessments, providing teacher/staff and family support training, providing top-tier case management services including crisis-intervention and de-escalation supports, and assisting with coordination of the delivery of services by site Student Assistant Specialists per the consultation model. The Service Agreement outlines with specificity the services to be provided at each site. The contract is available for review in the Special Education Office.

### FISCAL IMPACT

The fiscal impact for services with Stanislaus County Behavioral Health and Recovery Services will not exceed \$90,000 and will be funded by the Local Control Funding Formula (LCAP 3.3.i) and the Coordinated Early Intervention Services money used to reduce suspension and expulsion rates.

Total compensation does not include the agreement with Stanislaus Behavioral Health and Recovery Services for mental health support provided to students with disabilities through the IEP process.

School Districts are responsible for providing all Educationally-Related Mental Health Services (ERMHS) for students with an Individualized Education Program (IEP) since AB3632 was eliminated by the Governor's Line Item Veto in October, 2010. ERMHS are defined in the Individuals with Disabilities Education Act (IDEA) and include individual counseling, counseling and guidance, social work services, day treatment services, and residential services. Historically, these services were provided by County Mental Health Departments under AB3632 and relied heavily upon a medical definition of emotional disability rather than an educational model.

Modesto City Schools has received State and Federal funds to provide Educationally-Related Mental Health Services to the students within our District.

### ISSUE

Modesto City Schools has developed a Memorandum of Understanding (MOU) with Aspiranet to provide Educationally-Related Mental Health Services to the students requiring these services as determined by their Individualized Education Program. A copy of the MOU can be reviewed in the Special Education office.

### PROPOSAL

Aspiranet will provide in-home counseling support to students and their families transitioning back to Modesto City Schools from residential placements.

### FISCAL IMPACT

The fiscal impact for in-home counseling support with Aspiranet will not exceed \$20,000 and has been included in the Special Education Mental Health fund.





### BACKGROUND

There is a need in the Bret Harte Elementary School community to address the nutritional needs of hungry students and their families. United Way of Stanislaus County has developed a collaborative initiative to provide additional food to families in those communities and also teach them cooking methods using healthy ingredients.

### ISSUE

United Way of Stanislaus approached Modesto City Schools to collaborate in developing a program that would improve access to healthy food for families living in the Bret Harte community, as well as provide cooking and nutrition classes for them.

Modesto City Schools staff members met with the United Way of Stanislaus and the collaborating agencies for the CHEF Initiative – Second Harvest Food Bank and University of California Cooperative Extension – to determine food items, delivery dates, dates for classes, and communicating with families.

The Memorandum of Understanding (MOU) was for July 1, 2016 to June 30, 2017. United Way of Stanislaus and Modesto City Schools would like to continue the MOU for August 1, 2017 to June 30, 2018.

### PROPOSAL

United Way will provide healthy food to Bret Harte families by delivering supplemental food to the Bret Harte After School Education and Safety (ASES) program twice a month from August of 2017 through May of 2018.

Working with the University of California Cooperative Extension, United Way will provide cooking and nutrition classes for Bret Harte families each month from August of 2017 through May of 2018.





### BACKGROUND

The Federal Individuals with Disabilities Education Act (IDEA) and state law provide that special education students may be served by a state-approved Non-Public School (NPS) or Non-Public Agency (NPA) only when appropriate public placement or service is not available within the Special Education Local Plan Area (SELPA).

Modesto City Schools contracts with several NPS/NPAs to provide specialized educational services not available in District or County programs. A master contract is developed with each NPS/NPA which specifies the types of services authorized and the rates the District will pay for each service. When a student's Individualized Education Program (IEP) team determines that NPS or NPA services are required, an Individual Services Agreement is then executed which specifies the services to be provided for that student pursuant to the IEP.

School districts are also responsible for providing all Educationally-Related Mental Health Services (ERMHS) for students with an IEP since AB3632 was eliminated by the Governor's Line Item Veto in October, 2010. ERMHS are defined in the Individuals with Disabilities Education Act (IDEA) and include individual counseling, counseling and guidance, social work services, day treatment services, and residential services. Historically, these services were provided by County Mental Health Departments under AB3632 and relied heavily upon a medical definition of emotional disability rather than an educational model.

Modesto City Schools has received funds to provide Educationally-Related Mental Health Services to the students within our District.

### ISSUE

While the Modesto City Schools SELPA provides a wide range of special education services or contracts with the Stanislaus County Office of Education for such services, there are students with severe educational needs who require placement with an NPS or NPA. This includes out-of-state placements that would require reimbursement for any and all treatment and room and board costs, as well as travel costs associated with student placement and family visits. Master contracts with these providers are required.

These costs will be incurred for the 2017-2018 school year.

Taking Kare of Schools is a company that provides Automated External Defibrillators (AED) maintenance and services to school districts throughout the state of California. Taking Kare of Schools has a comprehensive knowledge of California Schools' AED legal requirements.

### ISSUE

The District has purchased fifty-nine (59) AED devices to be placed in all of our schools and in buildings around the District. The AED devices require ongoing servicing and maintenance throughout the year to ensure the devices are working properly.

### PROPOSAL

The District would like to establish an agreement for services with Taking Kare of Schools to provide servicing and maintenance based on said agreement. Services include but are not limited to checking and replacing any damaged or expired parts on the AED devices and other routine servicing and maintenance-related items. Varying services will be provided on a quarterly, biannual, and annual basis.

### FISCAL IMPACT



### BACKGROUND

Document Tracking Services (DTS) is a web-based application that allows school districts to streamline how they complete and update a wide array of school- and district-level reports. This application eliminates the need for faxing of documents, provides for more flexibility with school and district staff as the application is internet accessible, and it provides 100% accountability in tracking documents/reports.

Key features include:

- pre-population of all data needed in any report
- data carryover from year to year (minimizing/streamlining annual updates)
- full report customization
- complete document history/restoration
- multiple user logins per location
- translation services available upon request

### ISSUE

Our District is required to keep multiple and varied plans that contain the same informational components/data. DTS will provide the ability to streamline the input and maintenance of various plans while saving time and improving consistency across all District reports and plans. The application also provides for efficiency in pushing out various reports to the sites. Additionally, the LCAP must be posted in both English and Spanish. DTS can provide translation services as well, for a nominal fee.

### PROPOSAL

The District will continue with the services of Document Tracking Services to provide a non-exclusive license to use the DTS application for 34 school sites and the District Office – 35 sites total including up to five (5) different documents. Additionally, the District will continue to contract for translation services for the Spanish School Accountability Report Cards (SARC) for 34 school sites, 2017 Spanish Local Control and Accountability Plan, and 2017 Spanish Single Plan for Student Achievement. The term of the licensing agreement with Document Tracking Services is one (1) year and runs from July 1, 2017 through June 30, 2018.

FISCAL IMPACT

The contracted amount for Document Tracking Services includes a non-exclusive license to use the DTS application for 34 school sites and the District Office (35 sites total) including up to five (5) different documents, translation services for Spanish School Accountability Report Cards (SARC) for 34 sites, translation services for 2017-18 and 2018-19 Spanish Local Control and Accountability Plan; and translation services for 2017-18 Spanish Single Plan for Student Achievement. The total compensation to Document Tracking Services will not exceed \$38,000. The funding sources have been identified as categorical monies and in the Local Control and Accountability Plan (LCAP 3.1.h).

RECOMMENDATION





### BACKGROUND

California State Education Code 48985 requires, "If 15 percent or more of the pupils enrolled in a public school that provides instruction in kindergarten or any of grades 1 to 12, inclusive, speak a single primary language other than English, as determined from the census data submitted to the department pursuant to Section 52164 in the preceding year, all notices, reports, statements, or records sent to the parent or guardian of any such pupil by the school or school district shall, in addition to being written in English, be written in the primary language, and may be responded to either in English or the primary language."

### ISSUE

There are over 25 primary languages spoken within Modesto City Schools. In order to meet Education Code §48985, Modesto City Schools has been contracting with School Translations to provide translation services since 2004-2005.

### PROPOSAL

School Translations will provide written translations from English to Spanish or Spanish to English and other languages as needed during the 2017-2018 school year when bargaining members are not available or at times when we are unable to find a District translator in the needed language. A copy of the agreement is available for review in the office of State and Federal Programs.

### FISCAL IMPACT

The total cost of the agreement is \$30,000. The funding sources have been identified as categorical funds and in the Local Control and Accountability Plan (LCAP).

### ISSUE:






