Counts for 2013-14

September 30, 2013

### BACKGROUND

The District conducts enrollment head counts during the first month of the new school year for all the schools within the District. The enrollment counts are used as the basis for not only projections but many staffing and budget allocations.

### ISSUE

The first month final enrollment counts occurred on Friday, September 6, 2013.

### REPORT

#### K-6 Enrollment:

K-6 regular education enrollment of 11,965 is 25 more students than the final enrollment count for the 2012-13 school year and was 30 students more than projected. The largest increase was seen in third grade. With special education included, K-6 enrollment equals 12,332. Special education enrollment is not projected.

#### 7-8 Enrollment:

7-8 regular education enrollment of 2,903 is 72 more students than the final enrollment count for the 2012-13 school year and 56 students more than projected. With special education included, 7-8 enrollment equals 3,067.

#### 9-12 Enrollment:

9-12 regular education enrollment of 13,351 is 47 more students than the final enrollment count for the 2012-13 school year and 140 students more than projected. With special education included, 9-12 enrollment at the comprehensive high schools equals 14,022 students.

The total number of high school students enrolled at the Elliott Education Center is 554 students. This is 100 students less than the 2012-13 school year. Projections are not done for this program.

---

**Report on First Month Final Enrollment Counts for 2013-14****Summary Impact:**

The majority of the K-6 sites are again showing small to moderate growth. Beard, Fremont and Sonoma stand out as sites where student growth required the creation of new classes after the start of the school year. Only Orville Wright Elementary School showed substantial student decline.

Three out of four 7-8 sites had small growth, while Mark Twain Junior High School had a gain of almost two classes worth of students from the previous school year.

The 9-12 comprehensive sites showed overall growth of 47 students. The high school boundary change approved in February of 2013 showed the first signs of impact, better equalization of student enrollment versus capacity.


Enochs High School showed the desired decline in students while Davis and Downey have small increases in student enrollment. Johansen's enrollment decline should be stabilized by next fall as the boundary change will have greater impact in the out years. Modesto High School was essentially flat while Gregori gained 156 more students than last year, a phenomenon that may be attributed to a number of factors including students coming into the District on Inter-District Permits and families returning to public schools from private schools.

Total K-12 student enrollment with special education included is 29,975 or 35 more students from last fall and 226 more students than projected in January of 2013.

BACKGROUND

On September 4, 2013, Modesto City Schools received an electronic petition from Aspire Public Schools for sponsorship to renew its charter school.

ISSUE

Education Code 47605 (k)(3) requires a charter school that is granted its charter through an appeal to the state board and elects to seek renewal of its charter shall, before expiration of the charter, submit its petition for renewal to the governing board of the school district that initially denied the charter. If the governing board of the school district denies the school's petition for renewal, the school may petition the state.

PROPOSAL

Aspire Vanguard College Preparatory Academy, authorized by the California State Board of Education in 2009, serves students in the Modesto and Empire areas.

At a future Governing Board meeting, staff will make a recommendation to either approve or deny the petition based on criteria outlined in the Education Code for charter schools.

A copy of the petition is available for review in the office of the Associate Superintendent, Business Services.



### BACKGROUND

In order to receive funding for the Pupil Textbook and Instructional Materials Incentive Program (*Education Code*, Section 60252) and/or funding for instructional materials from any State source in a fiscal year, the district must meet the requirements of the *Education Code*, Section 60119.

### ISSUE

*Education Code* 60119 requires that the Board of Education shall hold a public hearing and shall make a determination, through a Resolution, as to whether each pupil in each school in the District has sufficient textbooks or instructional materials, or both, in each subject area that is consistent with the content and cycles of the curriculum framework adopted by the State Board.

### PROPOSAL

The local governing board of the Modesto City School District hereby certifies that as of this date, each pupil in the district at a K-12 traditional site has been provided with a standards-aligned textbook or basic instructional materials in each of the following areas:

- History/Social Science
- Mathematics
- Reading/Language Arts
- Science
- Foreign Language – 7-12
- Health – 7-12
- Laboratory Science Equipment – 9-12

For students in K-8 traditional education, the instructional materials were purchased from an approved standards-aligned state adoption list as required by *CCR, Title 5*, Section 9531.

For students in Grades 9-12, the instructional materials were adopted by the local governing board following district review of the materials and their alignment with State Content Standards as required by *CCR, Title 5*, Section 9531.

Public Hearing and Approval of Resolution 13/14-11  
that Modesto City Schools Provides Each Pupil at  
K-12 Traditional Sites Sufficient Textbooks  
and/or Instructional Materials

On July 28, 2009, Assembly Bill X4 2 (Chapter 2, Statutes of 2009-10 Fourth Extraordinary Session) suspended the process and procedures for adopting instructional materials, including framework revisions, until the 2013-14 school year. Senate Bill 70 (Chapter 7 of the Statutes of 2011) extended this suspension until the 2015-16 school year. Local boards have not, however, been relieved of their obligation to provide every pupil with textbooks or instructional materials and to hold the annual public hearing on instructional materials sufficiency required by EC §60119.

FISCAL IMPACT


Funds to purchase textbooks and instructional materials are budgeted from a variety of sources, primarily the K-8 and 9-12 Instructional Materials Program and Restricted Lottery funds.

---

### BACKGROUND

On October 4, 2010 the Board of Education took action to continue to reserve special tax dollars that had been collected by the Schools Infrastructure Financing Agency (SIFA) for the potential future construction of a standard competitive swimming pool at Enochs High School.

On January 14, 2013 the Board of Education authorized staff to hire an architect with the intent of developing preliminary pool drawings known as Design Development (DD) drawings, and to utilize this design to create an architect's estimate of probable pool construction costs.

On April 8, 2013 the Board of Education authorized the local architectural firm of Tim Huff and Associates, along with specialty pool consultant, Aquatic Design Group, to complete drawings, specifications and receive Division of the State Architect (DSA) approval.

### ISSUE

With DSA approval in place and funding identified, it is recommended that the project be authorized for competitive bid in accordance with Public Contract Code. All public works projects over \$45,000 must be competitively bid.

### PROPOSAL

It is proposed that the Enochs Standard Swimming Pool project be advertised for bid in the Modesto Bee, Builders Exchange and all interested contractors be contacted.

### FISCAL IMPACT

The architect's estimate of probable cost for this project is \$3,000,000; funding would be paid from the collected SIFA special tax dollars. There is no impact to the general fund at this time.

SIFA has collected \$2,951,900 towards the estimated project cost of \$3,000,000, leaving \$48,100 still to be collected from SIFA special tax areas outside of Village I. It is estimated that these funds will become available over the next year through special tax collections in the non-Village I special tax areas within SIFA.



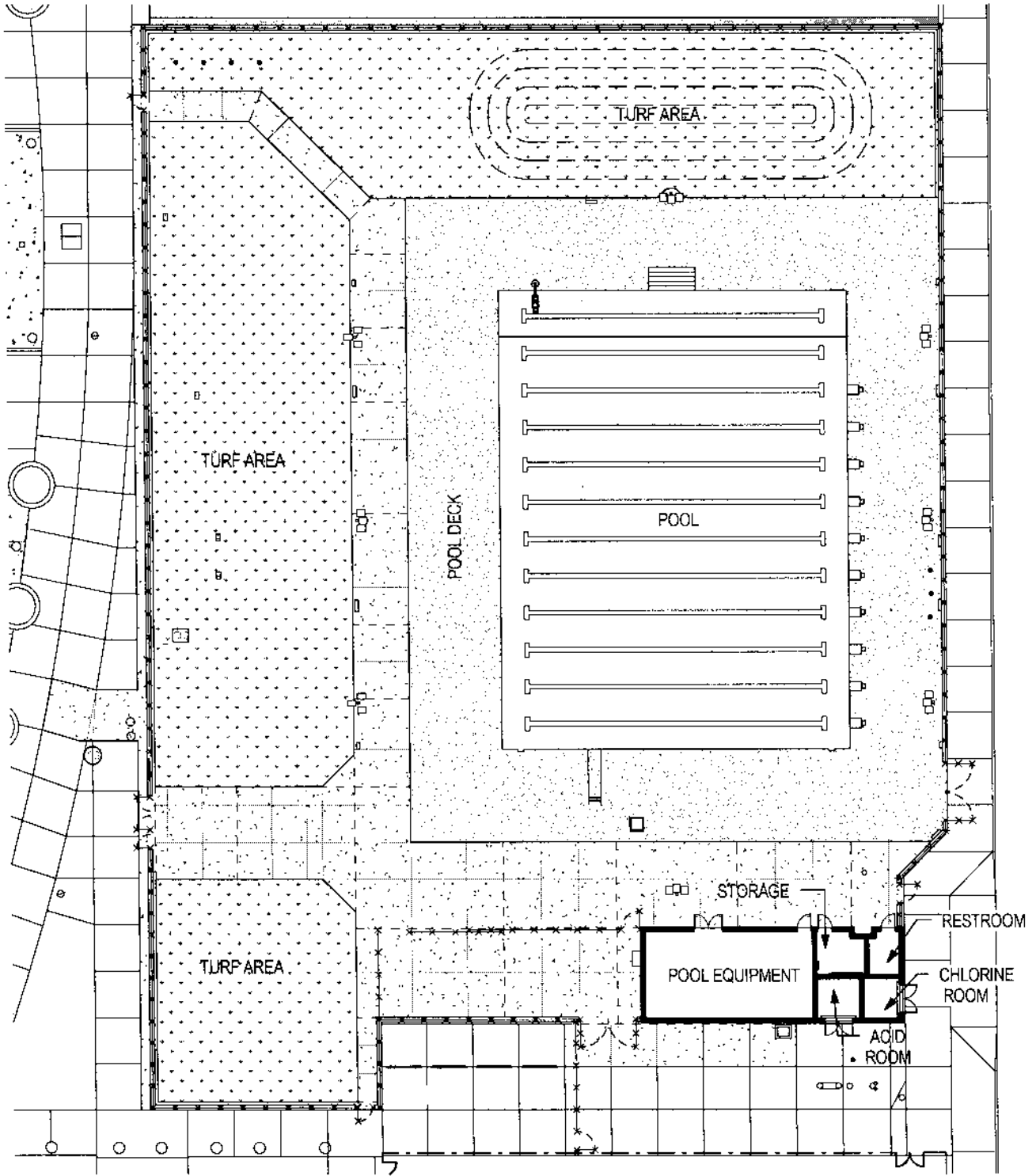

BACKGROUND

DataWORKS Educational Research was founded in 1997 with the single purpose of using real data to improve student learning, especially for low-performing students. Acknowledging that it is no longer enough to analyze test scores, their focus shifted to improving test scores by including measurements of classroom teaching practices. Focus on classroom instruction showed when teaching practices improved, student test scores improved as well.

ISSUE

Explicit Direct Instruction (EDI) is a strategic collection of instructional practices combined together to help teachers design and deliver well-crafted lessons that explicitly teach content, especially grade-level content, to all students.

PROPOSAL

With the success of the August 5 and 6 professional development for Explicit Direct Instruction with DataWORKS, it is proposed there be further professional development on EDI by DataWORKS. The emphasis will be threefold:

- Sites who have volunteered for extra training will focus on Lesson Demos.
- District Coaches will participate in Lesson Demos with inter-active coaching.
- On November 1, elementary teachers will participate in further EDI lessons with the focus on Skill Development, Concept Development, the shift to Common Core Standards, Vocabulary, or English Learners strategies.

Copies of the contracts are available for review in the office of the Associate Superintendent, Educational Services.

FISCAL IMPACT

The services agreement for the 2013-14 school year with DataWORKS was not to exceed \$155,000 and did not include the amendment for additional professional development noted above. The amendment to the existing services agreement would increase the compensation to DataWorks by \$458,197 for a total compensation not to exceed \$613,197. Funding will come from the QEIA grant, SIG grant, and both site and District categorical monies.







BACKGROUND

The existing playground equipment, play pits and fill material at Enslin, Everett, Fremont, Garrison and Kirschen Elementary Schools do not meet current standards as outlined in the National Playground Safety Act. To comply with these standards, redesigns for play pits to contain approved playground equipment and fill material have been completed.

ISSUE

With designs complete and funding identified, it is recommended that play structures be purchased. Competitive bids must be sought or identified to meet formal bid requirements. In order for the play structures to be on site when needed, orders need to be issued soon.

PROPOSAL

On October 31, 2012, the Houston-Galveston (Texas) Area Council, "H-GAC", awarded a public bid to Playworld Systems, Inc. for the purchase of parks and recreation equipment. The contract term is November 1, 2012, through October 31, 2014. The H-GAC contract contains cooperative purchase language that allows for other agencies to utilize it as required by provision 20118 of the Public Contract Code.

It is staff's determination that the District would derive more benefit by utilizing this cooperative bid contract than to seek separate bids.

FISCAL IMPACT

The preliminary estimate of probable cost for the purchase of play structures for all five sites is estimated not to exceed \$250,000. Funding for this project will come from the unrestricted General Fund, Board designation for Facility Maintenance.

BACKGROUND

On October 28, 2011 Bus #38 caught fire while parked at the District's Transportation Corporation Yard on Woodland Avenue. The incident occurred in the early morning so no driver, students or staff were on-board or injured.

The bus is a 2007 Crown and the fire was a result of an electrical malfunction. The bus was totaled and replaced by the District's insurance carrier.

Bus #38 has been dismantled for serviceable parts and has remained parked at the Transportation Corporation Yard.

ISSUE

Bus #38 must be disposed of and removed from the Transportation Corporation Yard due to the constraints on space at this facility.

PROPOSAL

It is proposed that Bus #38 be donated to the Westport Fire Protection District for training purposes. Westport Fire Protection District directly serves Fairview Elementary School. The Fire Protection District will use the bus for training at their facility and for training other public safety personnel who serve other Modesto City Schools' sites.

The alternative for donation is to sell the bus for scrap metal, estimated to be between \$1,000 and \$1,500. In addition to selling the bus for scrap metal, the District would incur the cost of transporting and other filing fees associated with this process.

Administrative Regulation 3270 provides the District with the Education Code authorization (E.C. 17546) and the process to donate, to a charitable organization, a District asset when the value of the asset is insufficient to defray the cost of arranging a sale. The Westport Fire Protection District is a public agency serving 42 square miles in the southwest portion of the District boundaries.

The Board of Education shall make this donation authorization by unanimously finding that Bus #38 has insufficient value to defray the cost of salvage or sale.

No Child Left Behind (NCLB) was signed into law by President George Bush on January 8, 2002. This law set up an accountability system for measuring Adequate Yearly Progress (AYP). Under this system, schools that fail to make AYP goals for two consecutive years become Program Improvement schools. Schools in their second or higher year of Program Improvement must offer students extra tutoring called Supplemental Educational Services (SES). Twenty-three (23) MCS schools are in their second, third, fourth, or fifth year of Program Improvement and must provide Supplemental Educational Services: Beard, Bret Harte, Burbank, El Vista, Everett, Fairview, Franklin, Garrison, Kirschen, Marshall, Martone, Muir, Robertson Road, Shackelford, Tuolumne, Wilson, Orville Wright, Hanshaw, Mark Twain, Davis, Downey, Johansen, and Modesto.

### ISSUE

Modesto City Schools is required to contract with California Department of Education (CDE)-approved providers for these Supplemental Educational Services. Parents have the right to choose a provider, and Modesto City Schools must contract with these organizations to provide extra tutoring. A Board-approved master contract with Supplemental Educational Services providers must be in place before services can begin.

### BACKGROUND

Youth for Christ Central Valley provides mentoring and counseling/professional therapy in one-on-one and/or small group settings, and conflict mediation in small group settings to students. These services are provided free of charge to students by volunteers, licensed Marriage and Family Therapists and Interns to help them discover, develop and maximize their potential.

### ISSUE

As part of Community Outreach and in accordance with new mentoring policies, the District is entering into a formal agreement for services that have been provided at no cost to Modesto City Schools by Youth for Christ.

### PROPOSAL

Youth for Christ Central Valley will provide mentoring in one-on-one and/or small group settings, counseling/professional therapy in one-on-one and/or small group settings and conflict mediation in small group settings to Modesto City Schools' students for the 2013-2014 school year.

Mentoring is performed by volunteer mentors. All counseling/professional therapy is done by licensed Marriage and Family Therapists and/or Marriage and Family Therapist Interns who are supervised by licensed MFTs. Conflict Mediation is performed by volunteers and/or MFT Interns under the supervision of a licensed MFT.

Youth for Christ will sign and adhere to the Mentor Contract and will ensure that every mentor has been cleared through their rigorous background check process which includes a social security number trace including aliases, multi-state search, National Sex Offender Registry, motor vehicle records search and county records in addition to the Department of Justice and FBI background check. They will also provide TB clearance within 60 days of starting the mentoring, counseling or mediation relationship.

### BACKGROUND

Modesto City Schools continues to hold the safety of all students as its highest priority. Creating a safe school environment is a constant process that must engage students, parents, teachers, administrators, and the community at large.

### ISSUE

In order to provide a safe school environment, activities are needed that are designed to foster unity, tolerance of diversity and camaraderie, to help reduce campus violence, decrease aggression and physical violence, and to help students develop empathy and resiliency skills.

### PROPOSAL

Youth for Christ has over 60 years in providing young people with basic life skills training, encouragement, and motivation. Youth for Christ's *Point Break* workshops are highly interactive and designed for groups of 35 – 80 students to participate in games, exercises in pairs, large group presentations, video clips, and small group experiences to achieve the goal of relational understanding and reconciliation between groups, races, and individuals.

### FISCAL IMPACT

Six one-day workshops at \$1,600 per workshop are scheduled at Enochs High School for a total not to exceed \$9,600. Lunch will be provided to the participants at a cost of \$200 per day for six days for a total not to exceed \$1,200. The total compensation to Youth for Christ for the *Point Break* workshops will not exceed \$10,800. Funding for the program will come from EIA-SCE monies.

Additionally, Youth for Christ received compensation for providing DISC-certified facilitator(s) at a cost not to exceed \$9,200. The total compensation to Youth for Christ to date is \$20,000.



Authorizing Assignment of Teachers Outside  
of Credentialed Academic Major or Minor Under  
the Licensing of Certificated Personnel Law for  
the 2013-14 School Year

---

### BACKGROUND

The services of teachers are required in subject areas other than those authorized by his or her credentials because of District need. The District may authorize staff who are holders of a General Elementary or Secondary Credential to teach outside of his or her college academic major or minor. Individuals holding Standard Teaching, Single Subject or Multiple Subject Credentials may be authorized to teach courses in Grades 7-12 other than those authorized by subject areas designated on their credentials.

### ISSUE

To qualify to teach certain classes, those teachers with the Standard Secondary or Single Subject credentials must have 18 semester hours of course work, or nine semester hours of upper division, or graduate course work in the subject area, or have completed at least 60 semester hours equally distributed among the four areas of a diversified major for instruction in a self-contained classroom, as set forth in Education Code Section 44263. For those with the Multiple Subject and Standard Elementary Credentials, it is necessary that they have 12 semester units or 6 upper division or graduate units to teach subjects in departmentalized settings in grades nine and below, as set forth in Education Code Section 44256. The holder of a Single Subject teaching or a Standard Secondary teaching credential may be partially assigned to teach classes in grades 5 to 8, inclusive, in a middle school, provided that he or she has a minimum of 12 semester units, or six upper division or graduate units, as set forth in Education Code Section 44258.2. A credential holder whose credential is in a subject other than physical education may be authorized, by action of the Governing Board, to coach one period per day in a competitive sport for which students receive physical education credit, as set forth in Education Code Section 44258.7.

### PROPOSAL

Based on the aforementioned Education Code Sections, a Board Resolution must be approved to allow teachers to teach courses that are both necessary and desirable for the efficient operation of the junior and senior high schools.

### FISCAL IMPACT

There will be no fiscal impact.



RESOLUTION NO. 13/14-13

WHEREAS, Education Code Sections 44256, 44258.2, 44258.7, 44263 were adopted by the California Legislature as part of the licensing of Certificated Personnel, provides that governing boards of school districts may annually adopt resolutions authorizing the holders of Standard Teaching, Single Subject or Multiple Subject Credentials to teach courses other than those authorized by the subject areas designated on their credentials or to authorize holders of General Elementary or General Secondary Credentials to teach outside of their college major or minor subject areas; and

WHEREAS, many situations arise in which assignment to teach such courses is both necessary and desirable for the efficient operation of the junior and senior high schools;

NOW, THEREFORE, BE IT RESOLVED that for the 2013-14 school year the Superintendent of the Modesto City Elementary District and Modesto City High District shall be authorized to assign teachers in accordance with the procedures enumerated and to delegate such authority as she deems appropriate to the Associate Superintendent, Human Resources.

A. Holders of Standard Teaching, Single Subject or Multiple Subject Credentials may be assigned to teach courses in Grade 7 through 12 other than those authorized by subject matters designated on their credential or holders of a General Elementary or Secondary Credential teaching outside of their college major or minor area, provided their services are required in other subject matter area because of the impracticality of scheduling them for a full program in the areas of their credential or college subject or no certified person is available who has the appropriate credential or college major; and

B. Holders of a teaching credential in a subject or subjects other than physical education may be authorized to coach one period per day in a competitive sport for which students receive physical education credit, provided that he or she is a full-time employee of the school district and has completed a minimum of 20 hours of first aid instruction appropriate for the specific sport.

C. Only teachers specifically listed in this resolution, including any teacher added to the list by any subsequent amendment to this resolution may be assigned in accordance with these procedures.






