This Memorandum of Understanding ("MOU") is written to modify the Collective Bargaining Agreement ("CBA") with regards to the Extracurricular Schedule

The parties agree to the following facts:

- The parties recently negotiated the 2018-2022 CBA
- The parties made adjustments to several Extracurricular Schedule Positions
- The parties wish to adjust another Extracurricular Schedule Position
- Nothing in this MOU alters the terms and conditions agreed to by the parties, except as explicitly stated within this document

Therefore, to bring the Chorus Extracurricular Position to a pay level comparable with the work involved for the position, the parties agree:

- The Chorus Extracurricular Position shall be increased in all columns of the 2018-2022 CBA, Appendix B to be equal to the Band Extracurricular Position listed in the CBA.
- Adjustments shall be made to the Chorus Position to ensure that the pay rate shall include retroactive payments, if applicable.

This Memorandum of Understanding shall be effective immediately upon execution by the authorized representatives as set forth below. This Agreement shall expire on August 31, 2022, when it shall be incorporated into a successor CBA, if such a document exists.
