<u>Preliminary Patron Insight Staff & Patron Report – Rick Nobles</u>

Mr. Noble with Patron Insight, summarized the online bond staff and patron survey. Heather Pruitt, a parent in the district was allowed by President Cunningham to address the Board in support of the Bond.

Bond Update – Rick Carpenter, Christina Medina

Mr. Rick Carpenter informed the Board that the Middle School project has been completed and that the work continues at Center High School.

Draft of Potential Bond Projects – Hollis & Miller

Mr. John Brown with Hollis & Miller presented a PowerPoint with various project options and costs for the bond. Koby Kampschreoder with Navitas joined the conversation. There were many question and much discussion between the Board, Mr. Carpenter, Mr. Kampschreoder and Mr. Brown.

Vice President Joe Nastasi added some historical context to the bond discussion after which President Cunningham asked for the following Motion.

MOTION TO PLACE A NO-TAX BOND ON THE APRIL 2, 2019 BALLOT WITH THE WORDING BELOW

Motion by Nastasi second by Stricklin for the District to place a no-tax bond on the April 2, 2019 ballot with the following wording. Motion passed with 5 approved and 2 opposed. Approved: Cunningham, Nastasi, Ball, Lahann, Stricklin

Opposed: Calvin, Kramschuster

Draft Ballot Language

Shall the Board of Education of Center School District No. 58 of Jackson County, Missouri be authorized to issue its general obligation bonds in the amount of \$48,000,000 for the purpose of renovating, improving, constructing, furnishing and equipping its school facilities, including but not limited to, (a) roof replacement and other facility repairs and long-term maintenance improvements, (b) installing energy conservation improvements, (c) improving safety through secure entrances and security cameras and (d) constructing, improving and adjusting facilities to allow for expanded early childhood programs, enrollment increases, family engagement and 21st Century learning; to the extent funds are available, resulting in no estimated tax increase to the debt service property tax levy? If this proposition is approved, the adjusted debt service levy of the

District is expected to remain unchanged at the current levy of \$0.90 per one hundred dollars assessed valuation of real and personal property.
