Report from Superintendent

CHS Spotlight – Mrs. Sharon Ahuna – Principal

Mrs. Ahuna presented a PowerPoint to the Board. Her PowerPoint included highlights in CHS academics, activities and athletics. Mrs. Ahuna introduced two CHS students, Jasmine Maqsood and Jayda Crawford, a freshman who shared their experiences as CHS students. There was discussion from the Board regarding parent engagement.

Kamela Bates, teacher at CHS, speaking on behalf of CEA, gave support of Mrs. Ahuna and staff on how well the school year has been.

Mrs. Wachel provided an overview of the Professional Development Committee, PDC.

Quarterly Financial Update – Dr. Michael Weishaar

Dr. Weishaar updated the Board on the district's current financial situation. He explained that the budget deficit is \$120,000 larger than previously shared. This deficit increase is due to staff raises for educational movement and hiring additional staff. He reported he would have a much better view in January 2018. Dr. Weishaar reminded the Board that the remote gate installation would be soon. He also mentioned that a cement slab would be installed behind the facility for an approximate change order total of \$5000.
