# As of 7-16-2020 PLEASE KEEP IN MIND ADH AND DESE GUIDANCE COULD CHANGE THE ANSWERS TO THESE QUESTIONS

The Greene County Tech School District will follow the Arkansas Department of Health (ADH) guidelines and the Arkansas Ready for Learning Report issued by the Department of Elementary and Secondary Education (DESE) in planning for re-opening of the school district in the fall. We hope the following information helps answer many of the questions and alleviate concerns about the reopening of schools.

The goal of the Greene County Tech School District will be to provide the safest learning environment possible which provides both a rich educational experience with learning opportunities for students including social interaction and extracurricular activities, while following the guidelines provided by the ADH.

Thank you for the responses to the planning survey, which provided valuable information to the faculty, staff, and logistics of safely planning for engagement during the fall of 2020. As GCT receives additional guidance and direction from the ADH, and DESE, the FAQ's will be revised and updated. Please visit the website often to receive updated information and receive notifications as procedures and guidelines are changed.

GCT is offering two options of learning for the 2020-2021 school year. Option one (1) is Blended (On Site) Learning. Option two (2) is Virtual (Off-Site) learning exclusively at home. At this time, there is NOT a plan to schedule alternating days or half days for students. All blended learning (on site instruction) will occur five (5) days a week.

## Option 1 BLENDED LEARNING (ONSITE LEARNING)-

Blended Learning (on site and remote learning) is a combination of face to face instruction in the classroom combined with technology components (Google Classroom and Zoom) both on campus and at home when school could be closed. Teachers will use Google Classroom for assignments, and while in the classroom teachers will also provide face to face instruction. A teacher will be in the classroom at all times to provide support and direction. Blended Learning means students will be on site for the school day, however, some classroom instruction can remotely be provided with the use of technology. The purpose of providing blended learning is to prepare students for any closures that could occur, and students will be prepared to participate in learning experiences at home using Google Classroom and Zoom.

# When is the first day for students who attend and commit to blended (onsite) instruction?

School will begin in the Greene County Tech School District on Monday, August 24, 2020. The date could change if the ADH or DESE sends updated guidance altering the beginning date of school for students.

## Will blended learning (onsite) be the same schedule as in the past?

The goal of the GCT School District is to provide the best educational experience for all students in a safe environment. The district is required to follow the guidelines as set by the ADH and DESE. Modifications to typical daily schedules on site may be necessary to meet the guidelines. Based on the current DATE and ADH guidelines, GCT will provide five (5) days of instruction PK-12 to students who are enrolled in blended learning.

## Will students attend school every day or will an alternative schedule be implemented?

Yes, students who attend school in a blended learning environment, will attend school every day, unless ADH and DESE guidelines alter the schedule.

## What will a normal day look like for a blended learning (onsite) student?

The goal of GCT is to provide a normal day as much as possible for students enrolled in blended (on site) learning while following safety guidelines outlined by the ADH and and DESE. The goal does NOT include keeping students confined to the same classroom all day long without any breaks, however modifications may have to occur in order to follow safety guidelines.

## Will water fountains be available?

Water fountains will NOT be available according to ADH guidelines. Parents are encouraged to send bottled water with students. The water should be clearly labeled with the student's name. Procedures will be provided to ensure that water bottles are filled during the school day as needed for students.

## Will students still have the same arrival and dismissal times?

Yes, each building will provide information on arrival and dismissal times for students. Maintaining the same district schedule is the goal to provide continuity in traffic flow.

#### Will classrooms be arranged differently to protect students?

Social distancing will be observed as much as feasibly possible but at times, students could be closer than the recommended 6 ft. apart. When social distancing requirements can not be maintained, such as class transitions, and etc., students will be expected to wear face coverings. Attempts will be made to redesign classrooms and support spaces to increase the 6ft suggested space between students but the recommended 6 ft apart may not always be available. Every effort will be made to provide distance but not limit students ability to interact and communicate with others in the classrooms. Supplies and materials should NOT be shared by students.

## Will students be socially distanced in the classrooms and will class sizes be reduced?

Every attempt will be made to keep students 6 ft apart following the ADH Guidelines, however, this might not be possible in all situations. Face masks will be required when social distancing is not possible.

## Will students eat lunch in their classrooms or in the cafeteria?

Based on current guidance, the ADH is recommending cafeterias limit the capacity of students in the cafeteria. We anticipate this may either mean adjusting lunch schedules or using alternative areas, such as larger gathering spaces. On a limited basis, some students could eat lunch in their classrooms. Proper sanitation of all areas will be completed after each meal. Procedures will not allow students to pick up utensils, self-serve or share food. Parents are strongly encouraged to open an online payment account for the purchase of ala carte items at the secondary level so cash is not exchanged. Parents are encouraged to send a water bottle with their students since water fountains with touchless refilling stations will be available.

## Will students be allowed to bring their lunch?

Based on the current guidelines, students can bring their own lunch.

## Will parents/guardians be allowed to drop off student lunches each day at specified times?

Due to safety concerns surrounding the COVID epidemic, outside lunches will not be able to be dropped off by parents/guardians.

## Will K-6 students still have recess?

Yes. K-6 students will have outdoor play time following the ADH restrictions, which could include limiting the number of students and playground equipment will be sanitized between groups of students. The district will still follow the heat and cold guidance in the parent/student handbook.

## How will transitions (changing classes) occur?

Transitions (changing classes) will be unique to each grade level and each building. Students may not transition for certain classes based on ADH guidelines, as teachers such as PACE, Art, and Music might transition to students. Students in grades 4-12 could transition throughout the school day and will be **required** to wear face masks during transitions. These procedures could change after further guidance is provided by ADH and DESE.

## Will students be able to participate in extracurricular activities and sports in the fall?

GCT will follow the Arkansas Activities Association (AAA) guidelines in accordance with the ADH guidelines provided to schools.

Will Primary, Elementary, Intermediate and MS 6th grade students still have PE, Art, Music, Guidance Class, Computers, Library, and Pace? Students will have special classes (art, music, library, computer lab, guidance, pace, and physical education). For PE classes, students may go to the gym,

where the area would need to be sanitized prior to other students being in the area. For the other special classes, the teacher may have to go to the classroom to deliver instruction.

## Will before and after care services be provided for GCT students enrolled in blended learning PK-6?

Yes, the district will follow the ADH guidance and is planning to provide these services. More information will follow.

# What special advice is provided with students with special needs (autism, asthma, panic attacks, anxiety, and etc.) or students with weakened immune systems and pre-existing conditions?

GCT is prepared to accomodate students through both blended learning (on site and remote) and Virtual Learning (off site) instruction for students with special needs. GCT Special Education instructors are taking precautions when working with students. If parents have concerns about their students who maybe at high-risk, because of COVID 19, they may explore the virtual learning (off site) option which allows the student to continue their education from the safety of their own home.

## What special precautions will be implemented in regard to cleaning and sanitizing?

Sanitation and cleanliness is a high priority for GCT. Building custodians will clean high touch surfaces (door knobs, light switches, and etc) and restrooms on a continuous basis throughout the school day. Specialized disinfectant sprays may be used to quickly sanitize rooms between usage. Also time will be provided for handwashing and hand sanitizing stations will be provided throughout campus. The district has purchased several misters to help provide additional sanitation.

#### If a student comes to school sick, what will happen?

If a student comes to school sick, the school nurse will screen the student and check, their temperature If temperature is over the ADH guidance,

the student will be sent home and will need to be fever free for 48 hours without medication before returning to school. When the child returns to school they will check in with the school nurse.

## If an individual tests positive for Covid-19, what will happen?

The ADH controls the procedures to follow once a staff member or student tests positive. GCT will follow the guidance and direction from the ADH.

## If 14 days of a self isolation or quarantine is required, will online instruction be provided to students?

Yes, during the time of quarantine, students will be allowed to participate in blended instruction with the use of

Yes, students should commit to attend for a semester however, extenuating circumstances may be considered.

### Will a teacher be teaching students who are enrolled in virtual learning?

Yes, virtual (exclusively online) learning students will have daily instruction provided by a teacher through the use of technology such as Lincoln Learning, and other technology programs.

## Will the virtual learning teacher be provided by a regular GCT teacher or provided through another provider?

Students enrolled in virtual (exclusively online) learning will have an assigned GCT teacher. The teacher will provide instruction and use a variety of learning platforms depending on the course/content.

## Will K-6 students be provided art, music, library, computer lab, guidance, and physical education virtually?

Yes, students will be provided these courses through virtual (exclusive off site) learning options.

## How will instruction be delivered virtually?

All instruction will be provided exclusively online. Students will NOT come on campus for instructional purposes, and will be assigned a GCT teacher. Students will be expected to participate in technology sessions variety of formats including but not limited to Lincoln Learning, Google Classroom, Zoom, and etc. Students may be required to be ONSITE for stated mandated assessments. ALL students (K-12) will be expected to participate daily in instructional activities. Students will follow all policies, handbooks, and procedures including attendance, assignments, and behavior. Secondary students will be taught by Arkansas Highly Qualified certified teachers licensed in specialized areas of instruction.

Will students be required to be online at specific times, and participate in classroom activities with Lincoln Learning, Zoom or Google Classroom? Students are expected to participate in daily learning activities and will need to meet specified deadlines for completing assignments.

# What grading practices will be used in virtual learning?

GCTVLA teachers will determine grading practices for all virtual learning courses.

## How will unfinished learning from last spring be addressed?

Students in grades K-8 may be administered diagnostic assessments to determine individual learning gaps. Students will be provided with support based on their needs. Courses will address unfinished learning by including essential standards that were not taught from the previous course.

## Will students still receive therapy services in virtual learning ?

Yes, with parental consent, therapy services will be provided and scheduled in a variety of ways.

## How will special education students receive services?

Students will continue to receive services included in their IEPS. Teachers and paraprofessionals will provide instruction through Lincoln Learning, google classroom and zoom.

## How will 504 students receive services?

Students will continue to receive the accommodations included in their 504 plans. Teachers and paraprofessionals will provide instruction and accommodations as listed on the 504 though Lincoln Learning, Google Classroom and Zoom.

## How will English Language Learners receive services?

Students will continue to receive services as outlined in the LPAC. Teachers and paraprofessionals will provide instruction through Lincoln Learning, Google Classroom and Zoom.

## Will Gifted and Talented (GT) students receive continued support and services?

Yes, GT students will receive online GT support and instruction through online learning systems.
