Line 3.020 Employee's Retirement/Insurance Benefits: Effective January 1, 2009, premiums for employee health insurance were reduced by approximately \$400,000 per year.

For calendar year 2008, teachers and administration agreed to a new health insurance plan with higher deductibles and out-of-pocket expenses, plus higher prescription co-pays. Beginning January 1, 2009, the support staff agreed to a similar plan plus incentives to opt out of the group health plan. The combination of these factors permitted lower premium rates for 2009. This cost savings is reflected on the attached Five-Year Forecast and effectively eliminates the projected deficit balance for all the years of the forecast.
