

LIONS WELLNESS CENTER MEMBERSHIP AGREEMENT

The Langford Area School District provides an opportunity for all community members to utilize a facility that not only promotes the fitness and overall health and well-being of our students and staff but all residents of our communities.

In accordance with SDCL 13-24-20, the school district grants use of the Lions Wellness Center (LWC) to persons who become members and agree to established rules and requirements. The membership will allow you access to the Wellness Center and Multipurpose gym. Members will be issued a key fob for the south Wellness Center door.

HOURS OF OPERATION

Wellness Center*

Monday-Sunday 4:00 AM – 10:00 PM

*The wellness center may be closed during school hours for PE Classes. A sign will be posted if closed and updated on the school's website under calendars then events calendar.

Multipurpose Gym*

Monday-Friday 4:00 AM – 8:00 AM & 5:00 PM -10:00 PM

Saturday-Sunday 4:00 AM – 10:00 PM

*The multipurpose gym is closed to members when special events have been scheduled.

MEMBERSHIP FEES

MEMBERSHIP RESTRICTIONS

- Members under the age of 18 must be accompanied by an adult who is at least 18 years old. This adult assumes the responsibility for the supervision of those under 18.
- A key fob can only be used by members who are at least 18 years old.

KEY FOB RESPONSIBILITIES & REPLACEMENT

- In lieu of a check-in sheet, all fobs must be swiped to gain entrance and log usage. When a group of members enter, each individual/family's fob should be swiped.
- Fobs can only be used by those included in the membership. Don't loan or give possession of your key fob to another person.
- Lost or damaged key fobs must be reported to the school's Business Office immediately.
- A \$25 fee will be charged to receive a replacement fob.

FOOD & DRINKS

- You may carry beverages in covered containers and bottles in the LWC and gym.
- NO FOOD or glass containers are allowed in the LWC or gym.
- Please properly dispose of all refuse in the trash receptacles.

CLEANLINESS:

- When finished, equipment should be wiped down with towels/wipes provided. Return all equipment to proper storage space and original settings after use.

OTHER GENERAL RULES for all members

- **ENTRANCE:** Members should enter and exit through the Southwest door only. All doors in the gym are fire exit doors only.
- **DOORS:** All doors should remain closed during your workout. Absolutely no propping of any doors is allowed.
- **SHOES:** Only indoor shoes can be worn in the LWC and multipurpose gym. Shoes that have been worn outside are not permitted in the LWC or gym.
- **LIGHTS:** All lights in the Wellness Center and men's & women's locker rooms are motion activated and will shut off after you leave. However, the lights in the gym WILL NEED TO BE TURNED OFF with the switches when you leave.
- **SMOKING, VAPING,** or the use of smokeless tobacco products is strictly prohibited.
- No outside equipment is allowed (skateboards, rollerblades, outside balls).
- Property damaged or destroyed due to negligence or intentional misuse will be repaired/replaced at the member's expense and may result in a loss of membership.
- **CONTACT US:** If you believe any piece of equipment is malfunctioning or is broken and in need of repair, please notify the school's office as soon as possible.
- The School Board reserves the right to modify, add or delete rules when necessary.
