September 9, 2019

The Cherokee County School District Board of Trustees met in regular session on Monday, September 9, 2019, at 5:30 PM in the Cafeteria at Alma Elementary School. Board members present were Chair Mr. Johnny Sarratt, Jr., Vice Chair Dr. Mark Nix, Secretary Mr. Matt Davis, Mr. Barry Bailey, Mr. Billy Blackwell, Mrs. Robin Harper, Mr. RJ Holly, and Mr. Kevin Phillips. Administrators present were Superintendent Dr. Dana Fall, Chief Human Resources and Operations Officer Dr. Carl Carpenter, Chief Academic Officer Dr. Shirley Sealy, Executive Director of Finance Mrs. Sherri Morgan, and Director of Food Service Sandra Littlejohn. Vice Chairman Nix called the meeting to order at 5:30 PM and led the invocation, followed by the Pledge of Allegiance.

Approval of the Consent Agenda approving the meeting agenda and the August 12, 2019, Board minutes was the next item on the agenda. Mrs. Harper made the motion to approve the consent agenda, seconded by Mr. Davis. Trustees voted unanimously for the motion.

Alma Elementary School Presentation – Mrs. Tracy Allison, Principal, was the next item on the agenda.
