Questions submitted and responses listed below as follows:

I've been looking over the bid information and I have one concern and question. You are requiring that
the new partitions be put on the existing track. The existing track's manufactures are both out of
business. Limestone-Central and Northwest both have Panelfold track and Grassy Pond have EMCO.
We could possibly find the Panelfold trolleys as they have been out of business only a couple of years.
The EMCO trolleys are no longer available as they as they have been out of business for over 20 years.
It may be possible to put the old trolleys onto the new panels but I would really have to do more
investigating and wouldn't advise to do that. In any case, we could not warranty the track or the trolleys.

Response: We would like for the new partition walls to be installed on the existing track, but we are open to additional options that include replacing the existing track. We have added two other options and revised the bidding schedule to reflect those additions. **VENDORS MUST USE THE ATTACHED BIDDING SCHEDULE TO SUBMIT THEIR BID.**

- Wall must meet or exceed fire retardant rating approved by the Office of School Facilities (OSF)
- Vendor must provide a detailed cut sheet to summarize the information and characteristics of the retractable partition wall with their signed bid. The cut sheet MUST state the fire retardant rating.
