Legislative: The long bill is done, but we are waiting to heave the governor's press release.

Superintendent Report: The District has a Daniel's Fund recipient: Madison Roth. We are currently working on several audits (ESSA/ESSER III, Student Count, At-Risk, Transportation). The District is looking at options for Athletic fees in the future since official fees have gone up so much.
