# **ACTION ITEMS**

**Staff Contracts:** Mr. Turrell presented probationary, non-probationary, classified, extra duty and coaching staff lists for approval for the 2023-24 school year. Mrs. Harris moved, Mr. Ebert seconded to approve the staff lists as presented.

**Salary/Benefits 2023-24:** Mr. Turrell reviewed the new funding coming from the state for next year. He provided information regarding several increases to the staff. Mrs. Harris moved, Mr. Messer seconded to approve a 20% increase for certified and administrative staff and a 10% increase for classified staff.

**Matching Funds – Faculty Scholarship:** Each year the Byers staff donates money to the faculty scholarship to wear jeans on Friday. This year, the staff donated \$550, so the Board will contribute \$1450.
