## Mayor and Mrs. Charles D. Hitchborn Scholarship

The *Mayor and Mrs. Charles D. Hitchborn Scholarship* has been endowed by a contribution from Charles "Chuck" and Joan Hitchborn, and is being administered through the Smithville R-II School District Foundation. The purpose of the *Mayor and Mrs. Charles D. Hitchborn Scholarship* is to provide financial assistance to a graduating senior from Smithville High School who plans to major in **Public Administration or Political Science and/or enter into a career of public service**.

**Scholarship Availability:** The *Mayor and Mrs. Charles D. Hitchborn Scholarship* will be awarded each year to a graduating Smithville High School student who meets scholarship qualifications. If no students qualify and/or apply for the scholarship during any academic year, no scholarship will be awarded.

## Qualifications for the Mayor and Mrs. Charles D. Hitchborn Scholarship are as follows:

- 1. The applicant must be 12<sup>th</sup> Grade student who is on schedule to graduate from Smithville High School;
- 2. The applicant must have earned at least a "C" average (2.0 grade point average on a 4.0 scale) in all course work through the first seven (7) semesters of high school.
- 3. The applicant must, in the opinion of the selection committee, have significant potential to be successful in public service;
- 4. The applicant must plan to enroll and pursue a Bachelors Degree in the field of **Public Administration or Political Science** at any College or University **and/or plan to enter into a career of elected public service following post-secondary studies**.
- 5. The applicant must submit two letters of support with the scholarship application, one submitted letter of support must be from a current or former Public Administrator/Public Servant or elected public official.
- 6. The applicant must submit an official transcript with the scholarship application.

**Scholarship Amount:** The *Mayor and Mrs. Chales D. Hitchborn Scholarship* will be renewable for four academic years. The four years of eligibility do not have to be consecutive school years, though funding for an individual will end within six (6) years of the granting of the scholarship. The amount of the scholarship is \$2000 for the freshman or first year of college attendance and sophomore, junior, and senior years of college \$1,000, or a maximum of \$5,000 per student for the duration of the scholarship. A scholarship recipient must provide documentation each year that he or she is satisfactorily pursuing a university major described in qualification #4 above to the Smithville Foundation treasurer.

**Selection Process:** A selection committee consisting of the Superintendent of Schools and Assistant Superintendents of Schools will review all applications based the applicant's application and potential in Public Administration and/or Public Service, a single application will recommended to the Smithville R-II Foundation Board for final approval. The recipient of *Mayor and Mrs. Charles D. Hitchborn Scholarship* will be announced at the spring senior awards ceremony.

**Deadline:** The deadline for the submission of applications for 2023 graduates is *Monday, March* 27, 2023. All application materials should be submitted to your building counselor by that date for consideration.
