## 2023 JUDGE LISA WHITE HARDWICK ACADEMIC EXCELLENCE SCHOLARSHIP COMPETITION:

The Jackson County Bar Association invites high school juniors and seniors to submit an essay. The essays should be no longer than 1000 words. The type font must be Arial, 12 point, double-spaced. The margins must be 1" and text must be fully justified. The essay MUST be accompanied by a Contestant Cover Sheet Form. The essay may be submitted as an attachment in Word format via e-mail to <a href="mailto:allison.williamson1980@gmail.com">allison.williamson1980@gmail.com</a>. The essay should address the following question:

Slavery enriched White slave owners and their descendants, and it fueled the country's economy while suppressing wealth building for the enslaved. The United States has yet to compensate descendants of enslaved Black Americans for their labor.

Many believe that reparations should be paid to American descendants of slavery to aid in correcting this injustice and to reduce disparities that remain pervasive in society.

If Dr. King were alive today, how would he suggest reparations be issued? How would Dr. King suggest reparations be financed and on what level?

Participants will be competing for cash awards at the local, regional, and national levels. The deadline for essay submission is March 25, 2023. Finalists will compete in the oral advocacy competition to be held on April 1, 2023. The competition will be held virtually this year.
