a. LOW PERFORMING STUDENT BLOCK GRANT PLAN

The LPSBG allocates \$300 million for LEAs, including county offices of education (COEs), school districts, and charter schools (both directly and locally funded) for the benefit of identified students during fiscal year (FY) 2018–19. These funds are designated to address the persistent achievement gap in California's public schools, and to provide resources and evidence-based practices to initiate and sustain authentic systemic change.

Grant recipients shall report to the State Superintendent of Public Instruction on or before:

March 1, 2019, regarding the adopted plan to use the grant funds to increase the academic performance of pupils identified pursuant to ECSection 41570(d).

November 1, 2021, regarding the implementation of the plan, the strategies used, and whether those strategies increased the academic performance of the pupils identified pursuant to <u>EC Section 41570(d)</u>.

Le Grand Union Elementary School received an apportionment in the amount of \$23,712. It is recommended that the governing board approve the LPSBG Plan for 2019-2021.

b. OUT OF STATE TRAVEL APPROVAL FOR SCOTT BORBA TRAVELING TO BOISE, ID FOR NAESP ZONE IX MEETING FEBRUARY 19-20, 2019

Mr. Borba is in his second year as the California state representative to the National Association for Elementary School Principals (NAESP). The annual Zone IX Meeting which will include representatives from Oregon, Washington, Idaho, Utah, Nevada, Arizona, Hawaii and California convenes to discuss their platform for the annual National Leadership Conference in Washington D.C. as well as share best practices in raising student achievement. All expenses are reimbursed by NAESP and ACSA, there is no cost to the district.

c. OUT OF STATE TRAVEL APPROVAL FOR SCOTT BORBA TRAVELING TO WASHINGTON D.C. FOR NAESP NATIONAL LEADERS CONFERENCE MARCH 16-21, 2019

Mr. Borba along with representatives from ACSA and the National Association of Secondary School Principals (NASSP) will meet with lawmakers in our nation's capital to lobby for additional services and funding for our schools. In addition to meeting with lawmakers, Mr. Borba will have the opportunity to network with school leaders from all 50 states regarding best practices for raising student achievement. Mr. Borba also sits on the "Big 10 Consortium" which represents the ten largest states in the country. All expenses are reimbursed by NAESP and ACSA, there is no cost to the district.
