The purpose of this request for proposal is to solicit from qualified vendors' proposals for Internet Access – installation, configuration and components to provide up to 1 Gbps Point to Multi-Point service between the Earlimart School District Office and Earlimart Elementary School and Alila School. These improvements will be performed as listed in the category of Telecommunications Service as defined by the SLD/USAC (E-Rate). All contracts are conditional of receipt of E-Rate funding and are not binding in the absences of such funding.

Proposal Requirements and Project Scope

• To enhance the learning environment and communication to students and staff members in the Earlimart School District.

- The service is to include all necessary components to support and sustain the capacity of Data Access at 1 Gbps and a potential growth to 10Gbs with an Ethernet Handoff via fiber or copper (where applicable).
- An approved agreement for Telecommunication Service (if necessary) will cover the period between July 1, 2019 and June 30, 2020 (Multi-Year Contract will also be considered).
- Qualified Vendors must clearly identify capabilities and associated charges for Service for the Earlimart School District and respective School Sites.
- Qualified Vendors must have customer support presence within 90 miles of the Earlimart School District Office to assure prompt service.
- Qualified Vendors must provide at least one primary contact number for customer service and related billing.
