# Fee for Service Waiver Guidelines 2022 - 2023

(Effective July 1, 2022 – June 30, 2023)

If your household income falls within the guidelines established by the Federal Government to qualify your child for free or reduced lunch prices, Attleboro Public Schools will waive the transportation fees for bus service. The guidelines presented here for 2022-2023 are preliminary and are subject to change.

## **How to apply for a Waiver of Fees**

### **Option A:**

- 1. Complete an application for Fee for Service Transportation in the Transportation Department.
- 2. Provide a copy of your 2021 1040 tax return along with copies of all W-2's in a sealed envelope for privacy purposes. You may omit any supporting schedules.

### **Option B:**

- 1. Complete an application for Fee for Service Transportation in the Transportation Department.
- 2. Provide all check stubs for the previous 8 weeks prior to submitting your application along with check stubs for **ALL** household members.
- 3. Please provide documentation for other items such as alimony, child support, and disability payments both regular and VA, social security or any other type of monetary funds received.

#### **Option C:**

- 1. Complete an application for Fee for Service Transportation in the Transportation Department.
- 2. If you currently receive SNAP or TANF, please provide a copy of your most recent approval letter from the Department of Transitional Assistance (DTA). The letter needs to be dated within the last six months of the Fee for Service application.

All information on your application and tax return will be kept in the strictest confidence. The application will be used for the sole purpose of determining eligibility for a waiver of transportation fees. A family may apply for a waiver of fees any time during the school year. If you do not qualify now but there is a change in the household income, please complete an application at that time.
