REPORTS:

STUDENT COUNCIL: Student Council President Mackenzee Fabel reported that District basketball games will begin Tuesday, February 16; an assembly for academic awards, honor roll and high honor roll was held January 25; Abby Curtis earned 3rd place at State Forensics, and she was also awarded a \$1,000 scholarship for SAE project in FFA.

CONSIDERATION OF EXTENSION OF FFCRA FOR CLASSIFIED: John Russ Hamilton moved to approve the extension of FFCRA leave for classified staff through the end of the school year, consistent with the certified staff. William Fabel seconded the motion. The district may use COVID relief funds to pay for this additional leave. The motion carried.

SPRING ENROLLMENT REPORT: The Board reviewed the enclosed enrollment information.

REQUIRED POLICY REVISION: The Trustees reviewed the revised policies #3110, #4215, #4332, #5223, and #5226, provided by MTSBA to align with recent changes to laws regarding weapons and marijuana. John Russ Hamilton moved to adopt the revised policies as presented, and William Fabel seconded the motion. The motion carried.

RESOLUTION FOR TRUSTEE ELECTIONS: John Russ Hamilton moved to approve the resolution for a high school election for two Alder trustee positions, one being a three-year term, and one being a two-year term. William Fabel seconded the motion, and the motion carried.

John Russ Hamilton moved to approve the resolution for an elementary election for two Sheridan trustee positions, each three-year terms. Klint Todd seconded the motion, and the motion carried.

RESOLUTION FOR MILL LEVY ELECTION: Therese Sutton moved to approve the resolution for a high school general fund mill levy election, and John Russ Hamilton seconded the motion. The motion carried.

PRINCIPAL RENEWAL/NON-RENEWAL: Superintendent Wetherbee recommended the renewal of Mr. Stout's elementary principal contract, stating that his evaluations are exemplary, and is work in the elementary building reduces the need for himself to be involved as the superintendent; additionally, he is easy to work with and understands the goals of the District. Therese Sutton moved to renew Mr. Stout's elementary principal contract, and John Russ Hamilton seconded the motion. The motion carried.

SUPERINTENDENT CONTRACT NEGOTIATIONS: Superintendent Wetherbee provided a survey of Class C superintendent salary and benefits packages. (See enclosed.) He pointed out that the state average for a total package is approximately \$102,000 per year. His current package costs the district approximately \$92,000 per year, and he asked for a salary increase resulting in a total \$100,000 package. John Russ Hamilton moved to approve a 10% increase to the current contracted salary of \$78,525 to bring the salary in line with the state's median. William Fabel seconded the motion and the motion carried.

READING AND/OR APPROVAL OF PREVIOUS MEETING(S) MINUTES:

Therese Sutton moved to approve minutes from January 12, 2021 regular meeting as presented. John Russ Hamilton seconded the motion. The motion carried.

REVIEW AND/OR APPROVAL OF CURRENT BILLS AND EXPENDITURE PROPOSALS:

Therese Sutton moved to approve the February warrant list as presented, including warrants #109321 through #109349 totaling \$49,754.25, and William Fabel seconded the motion. The motion carried.

Expenditures

Expenditure Proposals: Superintendent Wetherbee advised the Board that the concrete apron at the front entrance of the high school is becoming more of a concern; the concrete will need to be removed and replaced; this project will require a contractor, as it is beyond the capability of the Ag Construction class; there are several options, including adding heating element to it, but the final project will need to meet ADA requirements; the sidewalk is a concern as well, but any repairs made will not address the tree roots that are causing the cracks in the sidewalk; the trees and the sidewalk are town property; the concrete curb in front of the high school is crumbling as well, but it is also town property; the town is working toward improvements and renovations on Madison Street.

PRINCIPAL'S REPORT:

Principal Stout reported on the following:

Principal's Report

- Attendance K-6=95% 7-8=96%, 9-12=94%, and K-12=95%; he also reminded the Board that quarantined students participating in remote learning are not considered absent;
- January students of the month;
- Congratulated Kora Hardy and Tessa Scott for placing 1st and 2nd in the Energy Share Art Contest; Chloe Belk placed 1st and Addison Stout placed 2nd in an art contest sponsored by wildlife artist Derek Deyoung;
- 3rd Quarter mid-term is Feb. 11, and parent/teacher conferences are Feb. 25:
- The rooftop heating unit for the cafeteria, kitchen, library, and art room is not working; he is looking for bids to replace it; currently, he has one bid from Climate Control Inc. in Helena for \$28,700, which does not include the gas piping or high voltage electrical work.
- There are some other issues, such as window leaks, that will addressed by maintenance.

SUPERINTENDENT'S REPORT:

Superintendent Wetherbee reported on the following:

- Since the beginning of the school year, he has had 9 referrals for discipline with middle school students, which resulted in 2 suspensions and 7 lunch detentions; high school behavior has been limited to cell phones and dress code violations, resulting in 2 lunch detentions;
- The high school is remote learning at this time, but should be back Feb. 15:
- Middle school students were remote for a few days, but were back Feb. 8;
- Senior projects and pit cars are coming up;
- The basketball teams will play Lima basketball this weekend, and next week will have district play in games on Tuesday;
- He stated that MAPS scores are encouraging and he will share them with the board at the retreat.
