- C. You will confine your board action to policy making, planing, and appraisal, and will help to frame policies and plans only after the board has consulted those who will be affected by them.
- D. You will carry out your responsibility, not to administer the schools, but, together with your fellow board members, to see that they are well run.
- E. You will recognize that authority rest with the board of education and will make no personal promises not take any private action that may compromise the board.
- F. You will refuse to surrender your independent judgement to special interest or partisan political groups or to use the schools for personal gain or for the gain of friends.
- G. You will hold confidential all matters pertaining to the schools which, if disclosed, would needlessly injure individuals or the school. In all other matter, you will provide accurate information and, in concert with your fellow board members, interpret to the staff the aspirations of the community for its school.
- H. You will vote to appoint the best qualified personnel available after consideration of the recommendation of the chief administrative officer.
- I. You will support and protect school personnel in proper performance of the duties.
- J. You will refer all complaints to the chief administrative officer and will act on the complaints at public meeting only after failure of an administrative solution.
