The superintendent expressed his sympathy to the families of the children and adults who were killed in the School Shooting at the Covenant School in Nashville yesterday. As an educator and parent these events are always difficult to process and are troubling in so many ways. Please know that we will continue to make sure that the safety of our students and staff is always our top priority. That being said, last week we had a site visit from former police officer Mr. Lou Cammarata, who has worked for the Department of Homeland Security and is now a School Safety Specialist with the NJDOE. Mr. Cammarata observed our arrival, evaluated our facility, reviewed safety procedures, and observed a lock-down drill. After reviewing our procedures and meeting with our administrative team, I am pleased to report that the feedback from the visit was extremely positive and many of the recommended best practices in school security are already in place here at NPS.

The superintendent commented that the Second Trimester report cards were released on Friday in the Realtime Parent Portal.

The superintendent wished our students and staff the best of luck as they get ready to begin their run of fours shows of the musical Beauty and the Beast Jr., this Thursday, Friday, and Saturday.
