# **ACTION ITEMS**

**Approved Minutes of Regular Board Meeting April 12, 2018:** Mr. Brent Hallmark moved and seconded by Mr. Justin Wilson to approve minutes for the Regular Meeting April 12, 2018 Board meeting. The vote was unanimous.

**Approved action on approving contract with ESC11 for 2018-2019:** Mr. Jay Procter moved and seconded by Mr. Brent Hallmark. The vote was unanimous.

**Approved action on budget amendment:** Mr. Brent Hallmark moved and seconded by Mrs. Sonya Koke. The vote was unanimous.

I move to implement a program change in elementary and secondary fine arts-elementary music and secondary theater, based on the district's needs.
