# BOARD OF EDUCATION MINUTES NEWELL SCHOOL DISTRICT #9-2 February 11, 2019

#### I. Call to Order

### V. Presentation

**A.** Tracy Hansen from Ketel Thorstenson reported there is no change in the school audit process, which was completed in December. Same advice was given in regard to the tracking of capital fixed assets, but since the grant agencies and lending institutions have not had an issue with it, we will work on it as we go. Otherwise, the opinion is clean. Tracy went over the financial highlights with the budget committee before the meeting. Overall, there was positive changes in each of the funds, and the special education fund actual had a positive balance at the end of the year. The food service fund struggles and Tracy recommended budgeting for the transfer from general fund to food service so that it does not end the year with a negative balance. As the auditors look at the internal controls for the whole 2017-2018 school year, some of their findings on the audit have already been addressed and changed in January of 2018 when the last audit was completed but do not reflect until next year. Ketel Thorstenson does the Financial Statements and some adjustments so that was reported as a finding. The last finding was the final budget in September which setup to have a budget deficit, state law does not allow for that and a supplemental budget was not submitted to fix it.

- B. South Dakota School Board Recognition Week is February 18-22 and the School Board Members were presented with Certificates of Appreciation for all they do.
- C. Caleb McGregor, a freshman at Newell School, presented information about getting local beef into our school lunch program. (Farm to School Program) He heard about this program when Amy Pravecek

talked about Hulett, Wyoming implementing this opportunity into their school program. Caleb stated that our area produces some of the best beef in the national so why are we purchasing beef that contain additives? We could have local meat processed at a local locker. The local locker only needs to meet three requirements: 1. USDA state inspected, 2. Grade the meat, and 3. Met USDA nutrition values. Tri-County Locker has been talking to the Wall locker on what is all required to meet these specifications. He would like to educate the community and students about farm to school, and how they can help. He asked the school board, with the help of administration and the head chef, to see if he could put this plan into action. Questions, donated meat or how does a school start the process? The school could contract with local producers and the local locker. The board would need flow sheets to see the cost and meat differences. Hulett receives all donated meat and local donations and businesses help with the cost of processing the meat. Their beef consumption has tripled, because high students are eating at school and less sack lunches. Wall has started with donations as of last month. Currently, if we serve beef on a day, we use 60 pounds and current cost are between \$2.82 and \$1.89 a pound. The board thanked Caleb for the presentation.

D. Johnson Controls: Will Quinn, First, Johnson Control will be paying for the two values that may not meet the codes, they are talking to Frank Mortimer. The third boiler, they are going to start with replacing a spring and work on the regulator but the regulator may need to be replaced. The pumps are working the way they are supposed to. They will keep working on the water balancing and the classrooms in the lower elementary. If there are any other rooms, please let them know. They are still going to install the sheet metal for the vents and would like the board to pick a color.
