On roll call vote, the motion carried with five ayes. Toby Thompson abstained.

Mr. Luhr presented to the Board an array from area schools for administrative salaries. It was decided to go into executive session to discuss this further.

Mr. Luhr updated the Board on the NASB workshop and legislative conference that he attended last week.

Mr. Luhr discussed with the Board the staffing and facility needs for the 2019-2020 school year and also for the 2020-2021 school year. He has had two meetings to discuss these needs with both principals. After discussion, Lori Mink made a motion to hire two additional elementary teachers for the 2019-2020 school year due to increased enrollment in our elementary. Tammy Bierman seconded the motion. On roll call vote, the motion carried with six ayes.

Lori Mink made a motion to approve the option request of Isabelle Anderson, kindergartner, for the 2019-2020 school year. This request was based on available room in the class at this time. Toby Thompson seconded the motion. On roll call vote, the motion carried with six ayes.

Toby Thompson made a motion to approve the option request of Layne Bolduan, kindergartner, for the 2019-2020 school year. This request was based on available room in the class at this

time. Paul Kuchar seconded the motion. On roll call vote, the motion carried with six ayes.

Brent Bode made a motion to approve the option request of Elizabeth Staub, kindergartner, for the 2019-2020 school year. This request was based on available room in the class at this time. Lori Mink seconded the motion. On roll call vote, the motion carried with six ayes.

Lori Mink made a motion to approve the option request of Grayson Trice, kindergartner, for the 2019-2020 school year. This request was based on available room in the class at this time. Toby Thompson seconded the motion. On roll call vote, the motion carried with six ayes.

Lori Mink made a motion to deny the option request of Jett Spier, 9th grader, for the 2018-2019 school year. This request was based on our special education department is at its capacity. Toby Thompson seconded the motion. On roll call vote, the motion carried with six ayes.

Comments were heard from the Board, Principals, and Superintendent.

Brent Bode made a motion to go into executive session at 7:30 p.m. to discuss administrative salaries for the 2019-2020 school year. Paul Kuchar seconded the motion. On roll call vote, the motion carried with six ayes.

Paul Kuchar made a motion to come out of executive session at 7:59 p.m. Brent Bode seconded the motion. On roll call vote, the motion carried with six ayes. No action was taken by the board after coming out of executive session.

With no further business, Board President Jeremy Pochop adjourned the meeting at 8:00 p.m.
