All of the existing heating piping will be removed and all new changeover heating /cooling piping will be installed to each unit ventilator in every elementary classroom. The new, elementary classroom unit ventilators will have a higher delivered outside air flowrate than the existing units increasing overall ventilation rates. Additionally, new controls and CO2 sensors installed in the elementary classrooms will allow the unit ventilators to modulate their outside air dampers providing the proper amount of outside air based on classroom occupancy.
