**If you are a high school senior, submit your application to your high school guidance counselor where you attend high school. Do not send your application directly to the Foundation. The guidance counselor is responsible for submitting a packet of scholarship**

**applications to the Foundation. If you are a college student, you can submit your application directly to the Foundation at the address stated below.**

If you are chosen as a recipient of the Griffin Family Foundation Scholarship, **prior to July 15,** the recipient shall notify the Foundation **IN WRITING** as to the school the student will be attending and the address where the scholarship check should be mailed to the school. Prior to disbursement of the scholarship check, the recipient must agree to sign a statement authorizing the Foundation to communicate with the school of the recipient's choice and to obtain information from the school's files regarding the student's enrollment in the school, the use of the scholarship funds sent to the school by the Foundation and the student's scholastic record.
