THE PROCUREMENT PROCESS

NORTH CAROLINA GENERAL CONTRACT TERMS AND CONDITIONS (Contractual and Consultant Services)

1. GOVERNING LAW: This contract is made under and shall be governed and construed in accordance with the laws of the State of North Carolina.

- 1234604400. SITUS: The place of this contract, its situs and forum, shall be North Carolina, where all matters, whether sounding in contract or tort, relating to its validity, construction, interpretation and enforcement shall be determined
- 1234604401. INDEPENDENT CONTRACTOR: The Contractor shall be an independent contractor and as such shall be wholly responsible for the work to be performed and for the supervision of its employees. The Contractor represents that it has, or will secure at its own expense, all personnel required in performing the services under this agreement. Such employees shall not be employees of, or have any individual contractual relationship with the Agency.
- 1234604402. KEY PERSONNEL: The Contractor shall not substitute key personnel assigned to the performance of this contract without prior written approval by the Agency's Contract Administrator. The individuals designated as key personnel for purposes of this contract are those specified in the Contractor's proposal.
- 1234604403. SUBCONTRACTING: Work proposed to be performed under this contract by the Contractor or its employees shall not be subcontracted without prior written approval of the Agency's Contract Administrator/Project Designer. Acceptance of an offeror's proposal shall include any subcontractor(s) specified therein.

Upon the entering of a judgment of bankruptcy of insolvency by or against the Contractor, the Agency may terminate this contract for cause.

Neither party shall be deemed to be in default of its obligations hereunder if and so long as it is prevented from performing such obligations by any act of war, hostile foreign action, nuclear explosion, riot, strikes, civil insurrection, earthquake, hurricane, tornado, or another catastrophic natural event or act of God.

The minimum combined single limit shall be \$500,000.00 bodily injury and property damage; \$500,000.00 uninsured/underinsured motorist; and \$100,000.00 medical payment.

Providing and maintaining adequate insurance coverage is a material obligation of the contractor and is of the essence of this contract. All such insurance shall meet all laws of the State of North Carolina. Such insurance coverage shall be obtained from companies that are authorized to provide such coverage and that are authorized by the Commissioner of Insurance to do business in North Carolina. The contractor shall always comply with the terms of such insurance policies, and all requirements of the insurer under any such insurance policies, except as they may conflict with existing North Carolina laws or this contract. The limits of coverage under each insurance policy maintained by the contractor shall not be interpreted as limiting the contractor's liability and obligations under the contract.

The Contractor shall furnish a Certificate of Insurance as proof of the above coverages. Certificate will contain provision that the insurance coverages cannot be canceled, reduced in amount or coverage eliminated without 30 days' written notice to the Buncombe County Board of Education. Owner's Protective insurance must list the Buncombe County Board of Education as the "Certificate Holder", and as "additional insured". Owner's approval of Certificate of Insurance does not decrease or relieve the contractor's responsibility for maintaining insurance coverage as required in this Request for Proposal.

1234604415. ADVERTISING: Contractor agrees not to use the existence of this contract, the name of the agency, or the name of the State of North Carolina as part of any commercial advertising.

ENTIRE AGREEMENT: This contract and any documents incorporated specifically by reference represent the entire agreement between the parties and supersede all prior oral or written statements or agreements. The North Carolina General Assembly has amended the Statute to provide refunds of sales and use tax to local school units in accordance with the provisions of G.S. 105-164. 14(c) effective with tax paid on or after July 1, 1998.

These refunds are to include the "sales and use taxes paid by contractors on building materials, supplies, fixtures and equipment that become a part of or annexed to a building or structure that is owned or leased by the governmental entity and is being erected, altered or repaired for use by the governmental entity (G.S. 105-164.14)."

Sales and Use Tax Technical Bulletin Section 18-2F specifies: "To substantiate a refund claim for sales or use taxes paid on purchases of building materials, supplies. fixtures and equipment by its contractor, the claimant must secure from such contractor certified statements setting forth all the following information:

- a. the date the property was purchased;
- b. the type of property purchased:
- c. the project for which the property was used:
- d. if the property was purchased in this State, the county in which it was purchased;
- e. if the property was not purchased in this State, the county in which the property was used; and
- f. the amount of sales and use taxes paid.

In the event the contractor makes several purchases from the same vendor, such certified statement must indicate the invoice numbers, the inclusive dates of the invoices, the total amount of the invoices and the State and local sales and use taxes paid thereon. Such statement must also include the cost of any tangible personal property withdrawn from the contractor's warehouse stock and the amount of sales and use tax paid thereon by the contractor. Similar certified statements by his subcontractors must be obtained by the general contractor and furnished to the claimant. Any local sales or use taxes must be shown separately from the State sales or use taxes. PROJECT: Furnish all labor, materials, equipment and services, incidental and implied, for the removal of the old domestic boiler, tanks and heat exchanger and installation of (2) new HTP Phoenix Model PH199-119 water heaters.

SCOPE OF WORK: Work shall consist of furnishing all labor, taxes, materials, equipment, services, permits and startup incidental and implied, to install a complete work system as designed per the attached specifications.

- 1. Remove the existing boiler, tank and all unused piping, electrical components and wiring not needed for the operation of the new water heaters. Onsite dumpsters shall not be used.
- 2. Install (2): HTP Phoenix Model PH199-119 Modulating, High Efficiency, Condensing gas-fired water heaters.

The Water Heater System shall include (2) HTP Phoenix Model PH199-119 Modulating, High Efficiency, Condensing Gas Fired - Water Heaters, each with - 40 to 199 MBH Input - 119 Gallon Storage Capacity - 237 GPH @ 100 deg. F. rise (335 Gallons @ 100 deg. F. rise First Hour Rating). The water heaters shall be natural gas fired.

- The heater tank shall be constructed of 316L stainless steel. The primary condensing heat exchanger shall be constructed of 90/10 cupronickel. The secondary heat exchanger shall be constructed of 800H stainless steel and 90/10 cupronickel. The heater shall have an additional heat exchanger on the bottom of the tank to connect to a solar system.
- Tank insulation shall be 2" thick water blown foam. Insulation shall be enclosed in a plastic jacket. All components shall be located on the front of the heater for easy service access. All related hardware shall be constructed of stainless steel studs with brass nuts. All water connection nipples shall be constructed of stainless steel.
- The water heaters shall be ETL listed and certified to ANSI Z21.10.3-CSA 4.3 standard governing storage tank water heaters with input ratings above 75,000 BTU/Hr. Water heaters shall exceed the minimum thermal efficiency and standby loss requirements of the United States Department of Energy and current edition of ASHRAE/IESNA 90.1. All heaters will be supplied with a factory installed ASME rated temperature and pressure relief valve, a low water cutoff, a high temperature switch, an upper hot water sensor, a lower cold-water sensor, and a condensate trap assembly ready for easy connection to a field supplied condensate drain. The heater shall also include a condensate neutralizer.
- The heater shall have an integrated digital controller device with integral diagnostics, LED fault and temperature settings for establishing set point and temperature differential. Ignition shall be direct spark and take place at a speed pre-set for the burner blower. The control shall utilize an algorithm to fully adjust the burner modulating firing rate while maintaining the desired temperature. The pre-mix stainless steel burner uses a 120-volt motor with pulse wave modulation control to change the fan speed, thus the combustion air volume of fuel and air through the burner to establish a continuous BTU input range equal to the water heating set point requirement. The digital LED control display shall provide means, via push buttons, for adjustments of operating temperatures, differential adjustment, ECO reset, service mode, and real-time status mode. The control shall have low voltage inputs to accept a 0-10 volt from a building management system or outdoor sensor to alter the set point of the water heater. The unit will also have line voltage outputs for connection to a condensate pump and alarm output that will alert user of fault in the water heater for service. In addition, there shall be provided a computer connection for history, including all fault codes and hours of operation above 50% input, below 50% input, as well as real time status reporting of all operations. The burner assembly shall be mounted so as to be easily removed as an integral unit for ease of service.

- The heater shall be capable of either 2-pipe (intake and exhaust) closed combustion, or a single pipe system taking mechanical room air and piping exhaust outside. Venting shall be either Schedule 40 or 80 PVC or stainless-steel piping materials.
- The heater shall be in compliance with the NOx emissions limit set forth in SCAQMD Rule 1146.2. The heater shall be factory assembled, test-fired for correct BTU input, and adjusted for proper combustion parameters. Complete operating and installation instructions shall be furnished with every heater as packaged by the manufacturer for shipping.
 - 1. All piping, valves, venting and insulation shall be included.
 - 2. All wiring, accessories, disconnects shall be included.
 - 3. Factory Start-up, Adjustment & Combustion test report shall be part of this contract. Three copies of the completed factory start-up sheet, installation, operation and maintenance manuals shall be delivered to the owner before final payment will be made.

Contractor's Responsibility: The Contractor shall be responsible for the construction site during the performance of the work. The Contractor shall be responsible for all damages to persons and property during the performance of work and shall further provide all necessary safety measures and shall fully comply with all federal state and local laws, building rules, and regulations to prevent accidents or injury to persons or property on or about the location of the work site. This is to include OSHA 1910, General Construction, or those regulations mandated by these specifications. Special attention shall be made to proper barricading of the work area.

Safety Regulations: The Contractor shall adhere to the rules, regulations and interpretations of the North Carolina Department of Labor relating to Occupational Safety and Health Standards for the Construction Industry (Title 29, Code of Federal Regulations, Part 1926, published in Volume 39, Number 122, Part II, June 24, 1974 Federal Register) which is hereby incorporated in these specifications.

Codes: All work shall be performed in accordance with the specifications and shall comply with North Carolina Building Code, National Electrical Code Underwriters' Rules and Regulations and Federal, State and Local Regulations covering work of this nature. Whenever specifications are more than such laws, codes and regulations, the specifications shall hold. All equipment shall have U. L. labels attached.

Permits: The Contractor shall hold the appropriate license for work to be performed and shall secure all permits required for the job completion, obtain and deliver to Owner, all certification of inspection issued by the Authorities Having Jurisdiction. All final certificates must be delivered to owner prior to request for final payment.

Scheduling: The Contractor must submit a precise time schedule as to when specific work will occur in specific areas within the building. This will be used to coordinate the work with the occupants of the building. The Project manager or Principal may alter the schedule at any time to maintain the work process within the facility. Work must be scheduled during hours that are acceptable to each school and the Buncombe County Board of Education shall not incur any additional cost due to scheduling.

All work must be scheduled to avoid conflict with classroom instruction time and Cafeteria operation times and completed no later than August 17, 2019. All permits and inspections will be the responsibility of the contractor, and copies of permits and final inspection will be submitted to Buncombe County Schools prior to final payment.

Workers on Job: All employees of the Contractor shall, while on Buncombe County Board of Education property, act in a professional and courteous manner. All workers shall be expected to wear long pants and shirts while on Board property. Also, all employees of the Contractor must "sign in" in the main office upon entering the facility and must "sign out" upon leaving the property. Any employee of the Contractor may be told to leave the property by either the Principal or the Electrical Supervisor, if they do not follow the above procedure. The employee shall be replaced with another at no additional cost to the Buncombe County Board of Education. Smoking or use of Tobacco products is prohibited on Buncombe County School's property.

Equipment and Tools: The Contractor shall not use equipment or tools that are owned by the Buncombe County Board of Education. Also, employees of the Buncombe County Board of Education shall not be utilized by the Contractor except for opening locked doors and giving directions.

Materials: All materials stored on site must be stored in a safe and secure manner that does not interfere with the school's daily operation. Buncombe County Board of Education is not responsible for any materials, equipment or tools lost or stolen from the site.

Clean Up: The area of work shall be cleaned daily so that the Buncombe County Board of Education shall not incur any additional costs to make the area suitable for the work process. Also, the Contractor shall utilize no trash receptacles or dumpsters owned by the Buncombe County Board of Education. All trash and removed materials shall be properly disposed of off the property. Onsite dumpsters shall not be used.

Changes during project: Changes during the project shall only be made by written direction signed by the owner. No additional cost to the contract shall be allowed unless accepted in writing by the owner before work has begun.

Submittal: Within one week of acceptance of contract, performance data, installation manuals, operation manuals (3 copies) and time schedule must be submitted to the owner for approval. Send to Buncombe County Schools Maintenance, 175 Bingham road, Asheville, NC 28806, ATTN: Gerald Isbouts.

Payment: One block payment shall be made when all work is completed.

Final documents required:

- 1. Letter from contractor which states all work is completed and payment is desired.
- 2. Delivery to owner, all certifications of inspection issued by the authorities having jurisdiction.
- 3. Three copies each of: Owners manuals, Maintenance manuals and Manufacturer's start-up documents.

Performance of Work: All work shall be performed at the highest level of quality. The Owner shall be responsible for determining the quality of work, and may notify the Contractor of same. ANY WORK COMPLETED THAT IS NOT SUITABLE TO THE OWNER SHALL BE REPEATED BY THE CONTRACTOR AT NO COST TO THE OWNER. Any damage to existing area or utilities will be the responsibility of the Contractor. NO EXCEPTIONS.

Warranty: All labor, materials and equipment shall be unconditionally warranted for one (1) year from issuance of inspection "green tag".
