Changes to Specifications:

Section 02950 Sodding, Page 1, Paragraph 1.03 Warranty, Paragraph A, 1.

Change the following text: "warranty period shall extend through two planting seasons or nine months (whichever is longer) after the sod has been installed and accepted by the Owner." to "warranty period shall extend until October 31, 2018."

Change the following text: "All replacement sod shall be warranted and maintained for an additional period of one planting season.: to read: "All replacement sod shall be warranted and maintained until October 31, 2018".

Reminder:

Bidders are required to include a list of prime subcontractors (GC,PME) to be utilized on the project with their bid. If no prime subcontractors are utilized, the bidder shall declare that all work will be self performed. Include the subcontractor list in the outer envelope of the bid with bonds and MBE forms to allow determination if the proposal can be considered.

Introductions by all attendees:

Peter Looper with MHAworks presented the project schedule and key dates

Project Schedule:

April 20⁻ Bid Date (3 PM) in lieu of April 17 to be changed by Addendum #1 May 14- Notice to Proceed
June 14- Start Date in lieu of the June 11th to be changed by Addendum #1 August 20- Substantial Completion for Phase-1
September 28- Substantial Completion for Phase-2
October 28- Final Completion for Phase 1 & 2

Project Overview:

Mattern & Craig presented the Construction Documents via projected images.

- Discussed sequencing and the proposed Phases. Feedback indicated that both Phase 1 & 2 would likely proceed at the same time.
- The consensus was that both phases could likely be completed prior to the start of the 2019 school year (School starts on August 27, 2019)
- The Bio-Retention basin was discussed in detail. It is imperative that no silt enter the basin after the Bio Retention Media has been installed. It is up to the contractor on how best to accomplish this.
- Grass Seed vs Sod: It was suggested that the installation of Sod may be best to be able to avoid silt entering the Bio-retention basin.

- Discussion about the requirement to maintain the new grass for 1-year. It was
 determined that this requirement would add a good deal of cost to the project. The
 requirement will be changed in Addendum #1 to require the Contractors to maintain a
 full stand of healthy planted grass until October 31, 2018. The idea is that the grass
 should have time to become established and it will become dormant around the end of
 October.
- School water may be used to irrigate the new grass as long as the privilege is not abused; water may not be wasted. If the use of the school's water is abused the Contractor must transport water to the site to maintain the grass for the required period.

Other:

Last day of school June 13th, 2018
First day of School August 27, 2018
The Geotech report will be provided by Buncombe County Schools and issued via an Addendum when available.
